2. EPNG Pipeline Company (EPNG), a wholly owned subsidary of El Paso Natural Gas Company (El Paso), proposes to acquire certain pipelines and appurtenant facilites from All American Pipeline, L. P. (All American). As part of the acquisition process, EPNG is requesting the assignment of All American's interest in PRC 6783.1 and PRC 7527.2.
3. The California State Lands Commission (CSLC) acquired an interest in the lands covered by lease PRC 7527.2 through an exchange with the United States of America, Bureau of Land Management, by a Patent dated September 28, 1989. The Patent was issued to the CSLC subject to a Right of Way Lease issued to All American Pipeline Company, who later changed its name to All American Pipeline, L. P. The CSLC became the landlord of this Right of Way Lease and designated it as Lease No. PRC 7527.2.
4. Lease Nos. PRC 6783.1 and PRC 7527.2 authorized All American to construct, use, and maintain a 30-inch diameter petroleum pipeline which is part of a distribution system that transports petroleum across California and into Arizona and Texas. The pipeline has been used by All American to convey crude oil since its construction.
5. In addition to the request by EPNG to assign the interest in the leases, EPNG is proposing to convert the existing petroleum pipeline system to a natural gas pipeline system. El Paso has filed an application (Docket No. CP 00-422-000) with the Federal Energy Regulatory Commission (FERC) for the proposed conversion of the pipeline to natural gas for the portion of the pipeline that crosses Arizona and New Mexico. EPNG anticipates filing an application with the FERC and the CSLC for the conversion of the pipeline within California within the next few months. EPNG will maintain the pipeline in its current status until the environmental review process is complete and the conversion project has been considered by the CSLC.
6. On June 14, 1999, the CSLC consented to the encumbrancing of both leases and on March 23, 2000, the secured party lenders signed a partial release to the deed of trust which releases All American from the liens and security interests related to the encumbrancing document.
7. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of

the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.
