APPLICANT:

Vallejo Yacht Club P. O. Box 311 Vallejo, California 94590

AREA, LAND TYPE, AND LOCATION:

Granted sovereign lands with minerals reserved and ungranted sovereign lands in Mare Island Strait, city of Vallejo, Solano County.

AUTHORIZED USE:

Maintenance dredge a maximum of 100,000 cubic yards of material to maintain a navigable depth in the marina basin. Dredged materials will be disposed of at the United States Army Corps of Engineers approved Carquinez Strait Disposal Site (SF-9).

LEASE TERM:

Ten years, beginning November 1, 2000.

CONSIDERATION:

No royalty will be charged as the project will result in a public benefit; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304(g).




Site & Location Map
