#### **APPLICANTS:**

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Calaveras River, near the city of Stockton, San Joaquin County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing 20 foot by 23 foot single-berth floating dock and walkway.

#### LEASE TERM:

Ten years, beginning July 26, 2001.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### **SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$300,000.

#### OTHER PERTINENT INFORMATION:

On August 12, 1991, the Commission authorized a Recreational Pier Permit with Robert and Irene Hall. That lease will expire on July 25, 2001. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Robert and Irene Hall are now applying for a new Recreational Pier Lease.




