#### RECREATIONAL PIER LEASE

#### **APPLICANTS:**

Michael J. Logan and Mary Francis Logan 16841 Bolero Lane Huntington Beach, CA 92649

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Huntington Harbour, Huntington Beach, Orange County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing boat dock as shown on Exhibit A attached.

#### LEASE TERM:

Ten years, beginning February 22, 1999.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### **SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

#### OTHER PERTINENT INFORMATION:

1. On March 23, 1989, the Commission authorized a Recreational Pier Permit with Arthur Craig Johnson and Patricia C. Johnson. That lease expired on February 21, 1999. On September 13, 1995, Arthur Craig Johnson and Patricia C. Johnson deeded the littoral land to Michael J. Logan and Mary Francis Logan. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Michael J. Logan and Mary Francis Logan are now applying for a new Recreational Pier Lease.




