**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Kenneth Arthur Lester and Lana Christine Lester,  
Trustees of the Lester Family Trust dated April 18, 1991  
16821 Bolero Lane  
Huntington Beach, CA 92649

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Huntington Harbour, Huntington Beach, Orange County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing boat dock as shown on Exhibit A  
attached.

**LEASE TERM:**

Ten years, beginning March 23, 1999.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. On March 23, 1989, the Commission authorized a Recreational Pier Permit with J. Richard Stricker and Ireta Stricker. That lease expired on March 22, 1999. On June 8, 2000, J. Richard Stricker and Ireta Stricker deeded the littoral land to Kenneth Arthur Lester and Lana Christine Lester, Trustees of the Lester Family Trust dated April 18, 1991. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Christine Lester, Trustees of the Lester Family Trust dated April 18, 1991, are applying for a new Recreational Pier Lease.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

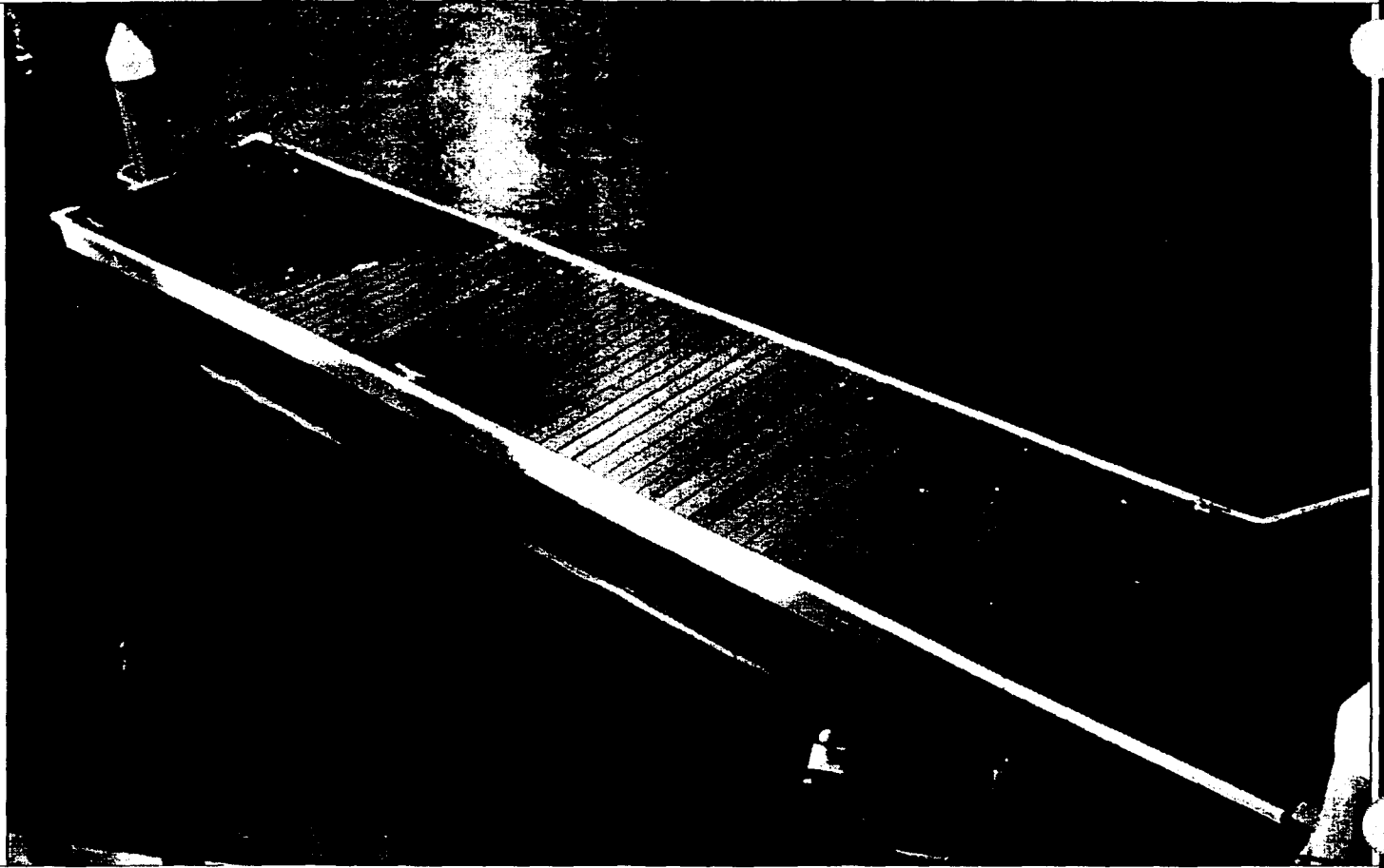

## LOCATION MAP

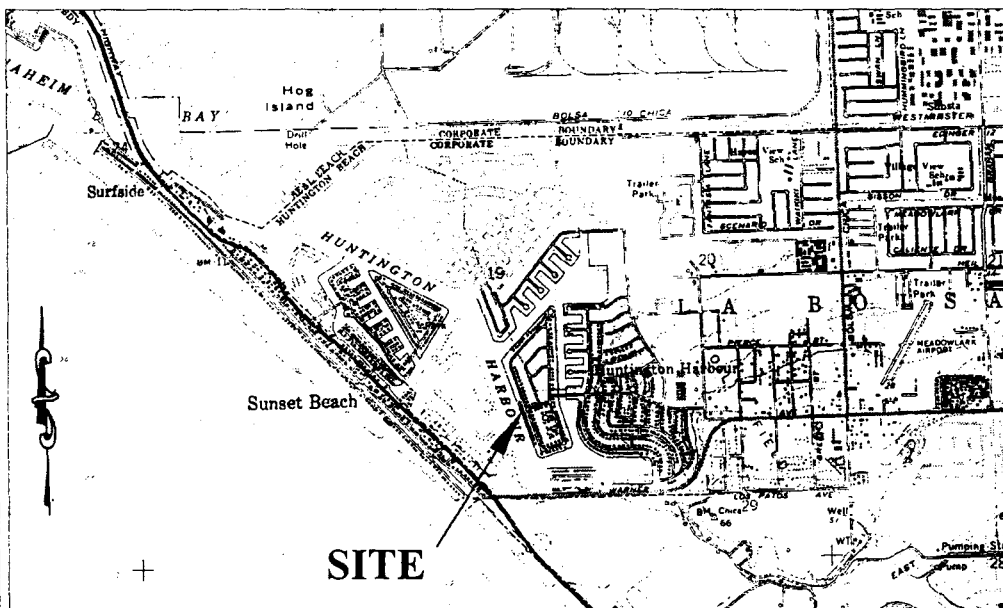
