**ASSIGNMENT OF LEASE
GENERAL LEASE- RIGHT OF WAY USE**

LESSEE/ASSIGNOR:

Louisiana-Pacific Samoa, Inc.
P. O. Box 158, 1 LP Drive
Samoa, CA 95564

ASSIGNEE:

Samoa Pacific Cellulose, LLC
P. O. Box 158, 1 LP Drive
Samoa, CA 95564

AREA, LAND TYPE, AND LOCATION:

9.045 acres, more or less, of submerged lands in the Pacific Ocean near Eureka,
Humboldt County.

AUTHORIZED USE:

Operation and maintenance of an existing 36-inch inside diameter wastewater
discharge outfall pipeline utilized in the processing of woodchips into bleached
pulp for commercial purposes as shown on the attached Exhibit A.

LEASE TERM:

30 years, beginning July 22, 1993.

CONSIDERATION:

\$6,314.40 per year; with the State reserving the right to fix a different rent
periodically during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

1. On July 19, 1993, the Commission authorized a General Lease - Right of
Way Use with Louisiana-Pacific Corporation. That lease will expire on
July 21, 2023. On July 19, 1998, Louisiana-Pacific Corporation assigned
the lease to Louisiana Pacific Samoa, Inc. Louisiana Pacific Samoa, Inc.

CALENDAR ITEM NO. C42 (CONT'D)

has now converted into a limited liability company named Samoa Pacific, LLC. Samoa Pacific, LLC is doing business in California under the name "Samoa Pacific Cellulose, LLC." Samoa Pacific Cellulose, LLC is now applying for an assignment of General Lease No. PRC 3186.1.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.

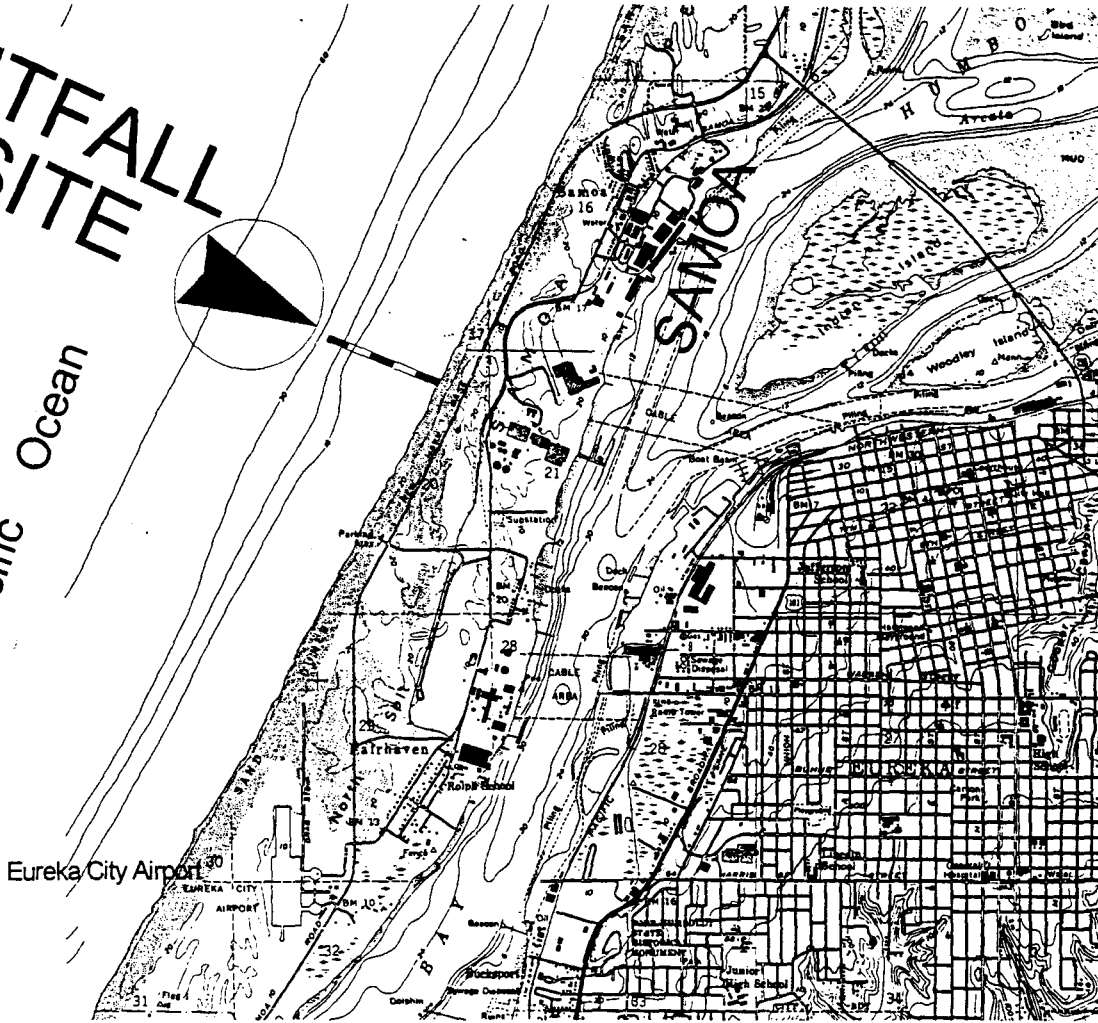
