## **BACKGROUND:**

At its meeting on June 27, 2000, the California State Lands Commission authorized the sale of royalty crude oil from several Oil and Gas Leases in Orange and Los Angeles Counties. Paramount Petroleum Company (Paramount) and Huntway Refining Company (Huntway), respectively, are presently purchasing the State's share of crude oil from these leases. Paramount and Huntway are paying the State a bonus of \$0.3510 and \$0.696 per barrel above a base price defined as the highest posted price among the posters in the respective oil fields. The State's share of production is approximately 1,100 B/D and 580 B/D respectively. The present royalty oil sales contacts are for terms of 12 and 18 months. Royalty oil from these leases may be taken in kind or returned to the lessee on 90 days prior written notice.

A Notice Inviting Bids for a new Royalty Oil Sales Contracts to run from June 1, 2001 until June 1, 2002 (Huntington Beach leases), and January 1, 2003 (Tract No. 2), was published in the Orange County Register and the Long Beach Press-Telegram on November 28, 2000, and sent to all known interested parties. Bids were received and opened on December 13, 2000. Exhibit A shows the results of the bidding.

## STAFF RECOMMENDATIONS:
