RECREATIONAL PIER LEASE

APPLICANT:

The Fox Lee Living Trust 13760 State Highway 160 Walnut Grove, California 95690

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, near the town of Walnut Grove, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing 10 foot by 20 foot floating dock and a 4 foot by 21 foot ramp.

LEASE TERM:

Ten years, beginning July 23, 2001.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503:5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On August 3, 1994, the Commission authorized a Recreational Pier Permit with Christopher Lee and Phyllis Fox Lee. That lease will expire on July 22, 2001. The Fox Lee Living Trust is now applying for a new Recreational Pier Lease. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling.

2. 


