NON-EXCLUSIVE RIGHT OF WAY LEASE

LESSEE:

Level 3 Communications, LLC
1025 El Dorado Blvd.
Broomfield, Colorado 80221

AREA, LAND TYPE, AND LOCATION:

0.47 acres of school lands located in Section 36, T 15 N, R 7 E, SBM, near Barstow, San Bernardino County.

AUTHORIZED USE:

The installation, operation, maintenance and use of 12 uncased high-density polyethylene (HDPE) innerducts, one of which will contain one fiber optic cable with approximately 144 fibers.

LEASE TERM:

Ten years, beginning April 1, 2001.

CONSIDERATION:

\$426 per year; subject to modification by Lessor as specified in Section 2 - Special Provisions and Paragraph 2(b) of Section 4 - General Provisions.

SPECIFIC LEASE PROVISIONS:

Insurance:

\$1,000,000 Combined Single Limit

Bond:

\$10,000

OTHER PERTINENT INFORMATION:

1. Section 36, T15N, R7E, SBM, near Silver Lake, San Bernardino County, is State-owned school land under the Commission's jurisdiction.
2. A Finding of No Significant Impact (FONSI) was prepared and adopted for this project by the United States Bureau of Land Management. The document was circulated for public review as broadly as state and local law may require and notice was given meeting the standards in Title 14, California Code of Regulations, section 15072 (a). Therefore, pursuant to Title 14, California Code of Regulations, sections 15221 and 15225, the staff recommends the use of the federal FONSI in place of a Negative Declaration.
3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
4. Level 3 Communications, LLC is constructing a national long-haul network for the transmission of voice and data services. The proposed project is part of the San Bernardino, California, to Las Vegas, Nevada, segment and will be approximately 256 miles in length. It will begin at Lessee's San Bernardino Terminal, end at its Las Vegas Terminal, and will be constructed within existing utility, roadway, and railroad right of ways.

The innerducts and the fiber optic cable will be installed underground in a trench which will measure approximately two feet wide and four feet deep with a minimum cover of 42 inches. The lease will authorize a 12-foot right of way.

5. The proposed project is contained within the area of the proposed expansion of the Fort Irwin National Training Center, East Gate Expansion Area. This lease contains a provision that should a sale or exchange of the school land parcel take effect, the lease will terminate.

AUTHORIZE ISSUANCE TO LEVEL 3 COMMUNICATIONS, LLC, OF A GENERAL LEASE - NON-EXCLUSIVE RIGHT OF WAY USE, BEGINNING APRIL 1, 2001, FOR A TERM OF TEN YEARS, FOR THE INSTALLATION, OPERATION, MAINTENANCE AND USE OF 12 UNCASSED HIGH-DENSITY POLYETHYLENE INNERDUCTS, ONE OF WHICH WILL CONTAIN ONE FIBER OPTIC CABLE WITH APPROXIMATELY 144 FIBERS ON THE LAND SHOWN AND

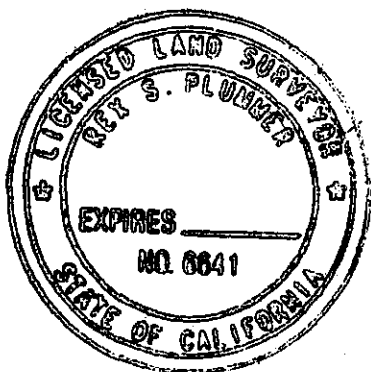


THAT PORTION OF SECTION 36, TOWNSHIP 15 NORTH, RANGE 7 EAST, SAN BERNARDINO BASE AND MERIDIAN, IN THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A 12-FOOT WIDE STRIP OF LAND LYING 6-FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

BEGINNING AT THE NORTHWEST CORNER OF SAID SECTION 36; THENCE ALONG THE WEST LINE THEREOF SOUTH 00°10'52" EAST A DISTANCE OF 998.55 FEET TO A POINT LYING 195.00 FEET NORTHWESTERLY MEASURED AT RIGHT ANGLES FROM THE SOUTHEASTERLY LINE OF THE INTERMOUNTAIN POWER AUTHORITY RIGHT-OF-WAY AS SHOWN ON THE RECORD OF SURVEY FILED IN BOOK 62, PAGES 6 THROUGH 16, IN THE OFFICE OF THE COUNTY RECORDER OF SAN BERNARDINO COUNTY, SAID POINT BEING THE **TRUE POINT OF BEGINNING**; THENCE NORTH 53°08'17" EAST, PARALLEL WITH SAID SOUTHEASTERLY RIGHT-OF-WAY, A DISTANCE OF 1702.56 FEET TO THE NORTHERLY LINE OF SAID SECTION 36 AND THE **POINT OF TERMINUS** OF SAID STRIP OF LAND.

THE SIDELINES OF SAID STRIP OF LAND SHALL BE LENGTHENED OR SHORTENED SO AS TO TERMINATE SOUTHWESTERLY ON THE WEST LINE OF SAID SECTION 36 AND NORTHEASTERLY ON THE NORTH LINE OF SAID SECTION 36.

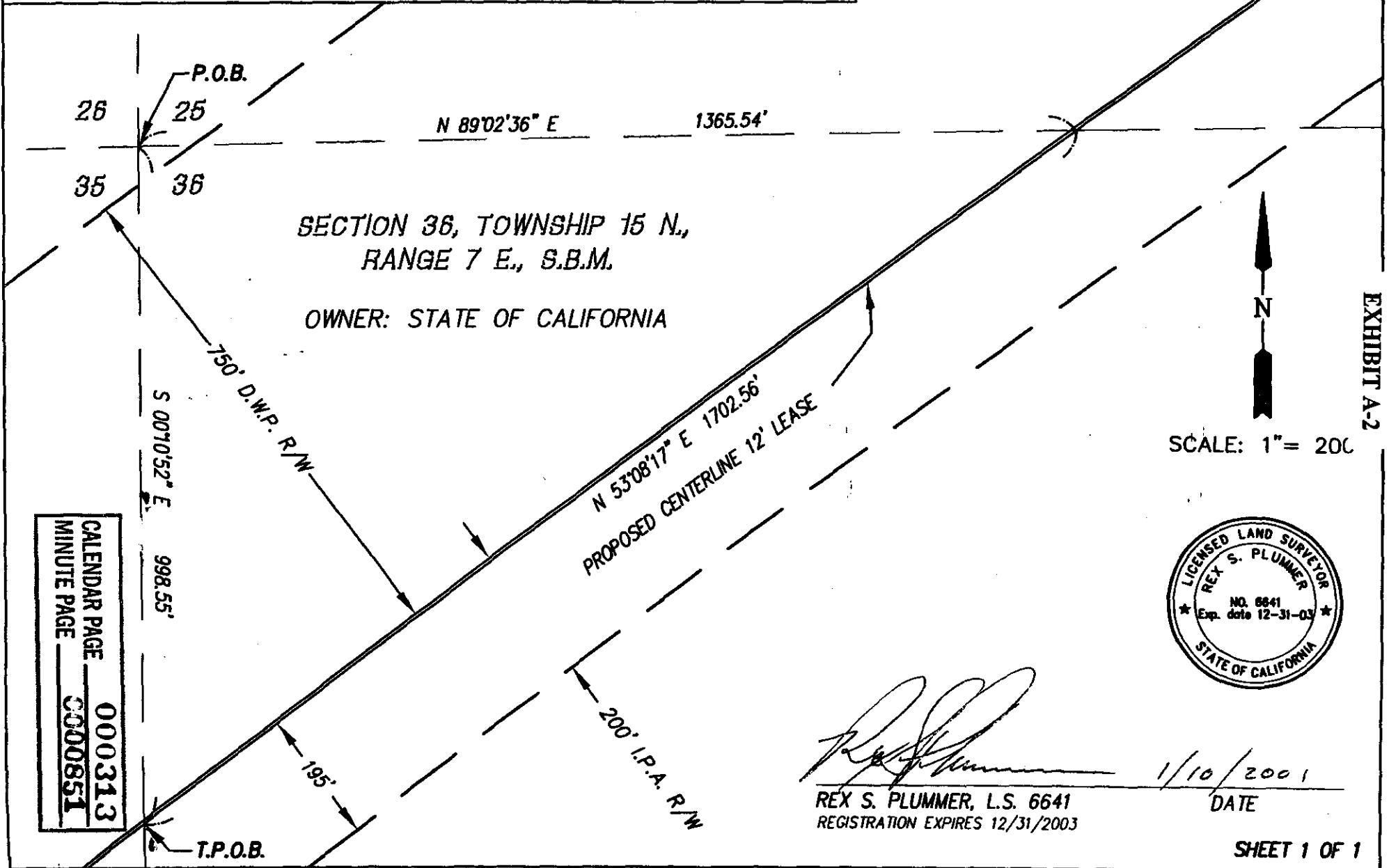

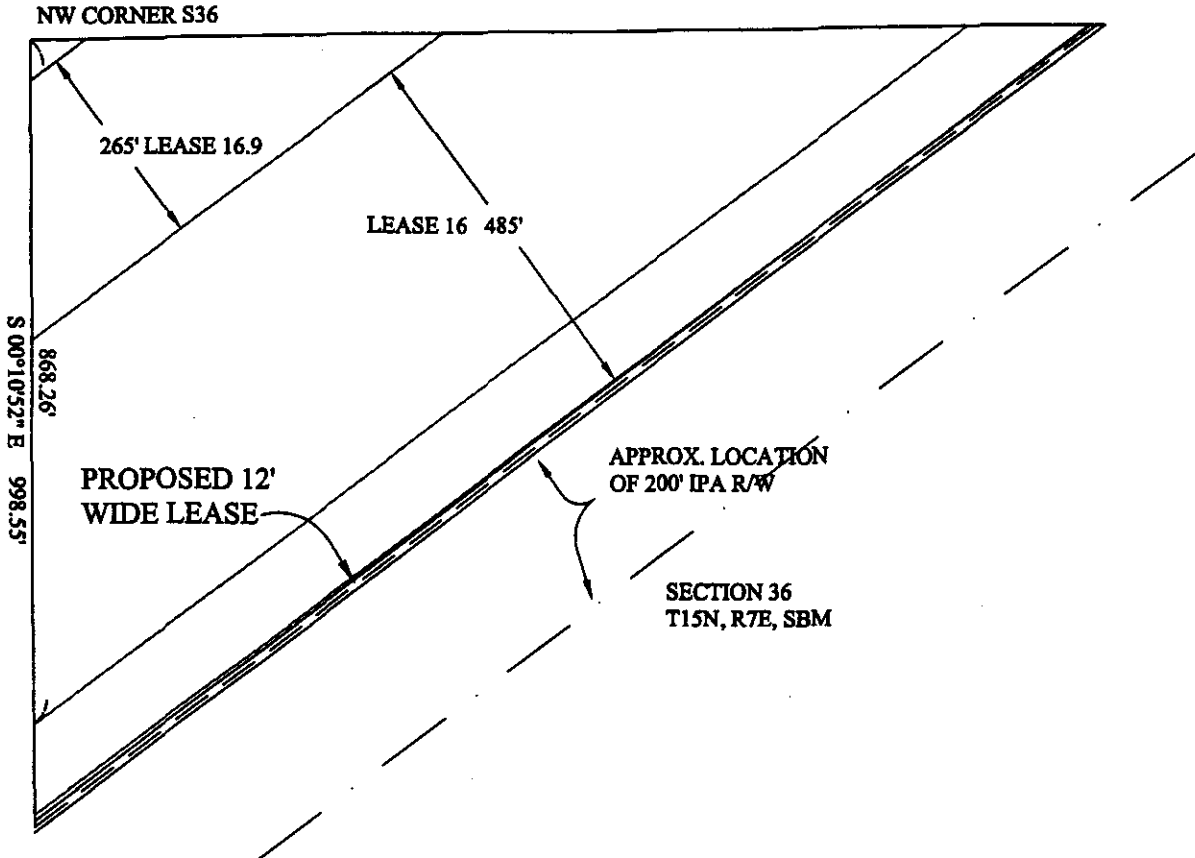

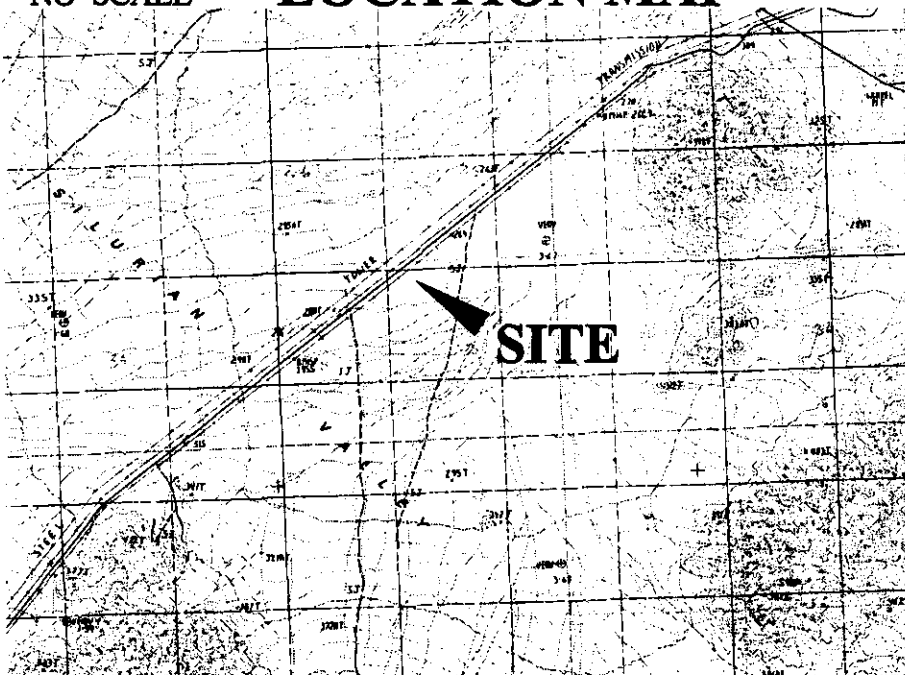
SITE MAP
