# **AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Steamboat Slough, near Walnut Grove, Solano County.

# **AUTHORIZED USE:**

Continued use and maintenance of an existing 20 foot by 10 foot landing pad, a 12 foot by 4 foot ramp, and a 6 foot-3 inch by 31 foot-9 inch floating boat dock.

# LEASE TERM:

Ten years, beginning March 5, 2001.

# CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

# SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

# OTHER PERTINENT INFORMATION:

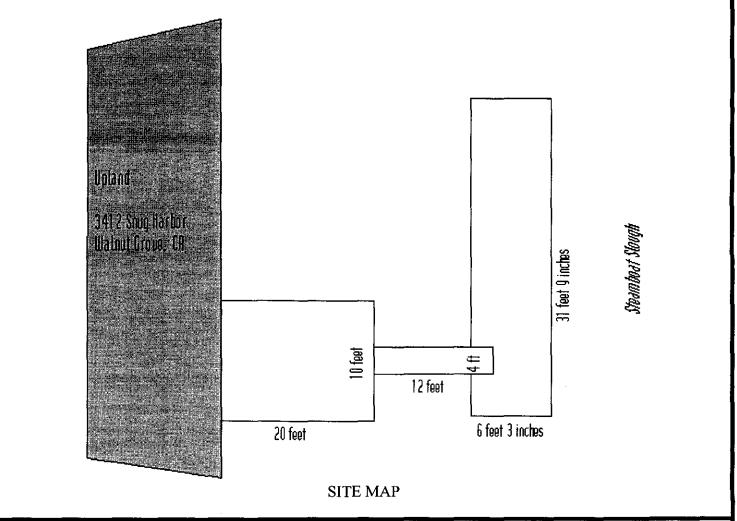
