### AMENDMENT OF LEASE

#### LESSEE:

Lodi Gas Storage, a Limited Liability Company 1822 W. Kettleman Lane, Suite 3 Lodi, California 95242

### AREA, LAND TYPE, AND LOCATION:

1.34 acres, more or less, of tide and submerged lands in the Mokelumne, North and South Mokelumne rivers, Georgiana, Threemile, Jackson and Tomato sloughs, near the city of Lodi, Sacramento and San Joaquin counties.

### **AUTHORIZED USE:**

Installation of a 24-inch diameter high-pressure gas pipeline connecting the existing Pacific Gas and Electric Line 401 at Sherman Island to the Lodi Gas Field located approximately 5.4 miles northeast of the city of Lodi to provide natural gas storage and hub services to natural gas consumers, utilities and marketing companies.

### LEASE TERM:

20 years, beginning September 19, 2000.

### **CONSIDERATION:**

\$1,070 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

### **PROPOSED AMENDMENT:**

Amend the legal description by deleting Exhibit A-6 from said Lease and replacing with the new Exhibit A-6. All other terms and conditions of the lease shall remain in effect without amendment.

### OTHER PERTINENT INFORMATION:

- 1. Applicant has the right to use the uplands adjoining the lease premises.
- 2. On September 19, 2000, the California State Lands Commission (CSLC) approved the issuance of a 20 year General Lease – Right of Way Use No. PRC 8207.1 to Lodi Gas Storage, LLC, for the installation of a directionally bored single 24-inch diameter gas pipeline under the Mokelumne, North and South Mokelumne rivers, Georgiana, Threemile, Jackson and Tomatos sloughs, Sacramento and San Joaquin counties. No construction on the pipeline crossings has begun. The Board of Trustees of the Brack Tract Reclamation District 2033 has requested that Lodi Gas Storage select an alternate crossing under the South Mokelumne River, due to soil stability concerns. The owners on the other side (west side), Staten Island, have no objection to this alternate location. The alternate crossing is to be located approximately 200 feet north of the existing pump station.
- 3. An EIR was prepared and certified for this project by the California Public Utilities Commission (SCH 1999022065). The CSLC staff has reviewed such document and Mitigation Monitoring Program adopted by the lead agency.
- Findings made in conformance with the State CEQA Guidelines (Title 14, 4. California Code of Regulations, sections 15091 and 15096) are on file in the office of the CSLC.
- A Statement of Overriding Considerations made in conformance with the 5. State CEQA Guidelines (Title 14, California Code of Regulations, section 15093) is on file in the office of the CSLC.


