RECREATIONAL PIER LEASE

APPLICANT:

Michael David Souza 511 W. Brannan Island Road Isleton, California 95641

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the San Joaquin River, Andrus Island, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing 26 foot by 34 foot single-berth boat dock and a 2 foot by 20 foot ramp.

LEASE TERM:

Ten years, beginning May 7, 2001.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. On March 1, 1995, the Commission authorized a Recreational Pier Permit with Edward H. Grogan III. That lease will expire on February 28, 2005. On August 14, 1997, Edward H. Grogan III deeded the littoral land to Michael David Souza. Michael David Souza is now applying for a new Recreational Pier Lease. Applicant qualifies for a Recreational Pier Lease because the Applicant is a natural person who has improved the littoral land with, and uses the upland for, a single-family dwelling.




