REVISION OF RENT

LESSEE:

Tri Valley Oil and Gas Company 230 South Montclair, Suite 101 Bakersfield, California 93309

AREA, LAND TYPE, AND LOCATION:

1.75 acres, more or less, of tide and submerged lands in Piper Slough, Frank's Tract, and False River between Bethel Island and Webb Tract, Contra Costa County.

AUTHORIZED USE:

Continued use and maintenance of a six-inch diameter welded steel natural gas pipeline to provide a pipeline connection for Tri Valley's existing Webb Tract No. 1 gas well on Webb Tract connecting to Tri Valley's existing Martins-Severin gas gathering system near Bethel Island.

LEASE TERM:

20 years, beginning October 16, 1996.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$221 per year to \$262 per year, effective October 16, 2001.

The recommended rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). The adjustment does not obligate the Commission to use the CPI to adjust future rents.


