AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the San Joaquin River at Andrus Island, near the city of Isleton, Sacramento County.

AUTHORIZED USE:

The construction, use and maintenance of a 50 foot by 40 foot boat dock consisting of a single 40 foot by 15 foot boat berth, a 10 foot by 40 foot walkway, and a 4 foot by 30 foot metal gangway.




