Sovereign lands in Lake Tahoe, Bijou, El Dorado County.

- 1. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Lawrence W. Hrubesh and Mary L. Hrubesh are applying for a new Recreational Pier Lease.
- 2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. 
