## APPROVAL OF BOUNDARY LINE AGREEMENT ESTABLISHING PROPERTY LINES AT BLOODY ISLAND, TEHAMA COUNTY

#### **APPLICANT:**

Charles Orwick

# **BACKGROUND:**

This action involves a 52.56 acre parcel of land along the east bank of the Sacramento River approximately 10 miles northerly of the City of Red Bluff in Tehama County. It has its roots in citizen complaints about denial of fishing access along the Sacramento River in 1975. In March, 1976, the Commission authorized a quiet title action which was filed as State v. Orwick, Tehama County S.C.C.# 18801 which was filed in July, 1976. At the conclusion of the litigation, judgment was rendered in favor of the State on August 14, 1979 and recorded December 20, 1983.

#### **CURRENT SITUATION:**

Unfortunately the judgment did not clearly adequately describe the lands confirmed to the State. A Boundary Line Agreement was drafted and approved by the Parties in 1987. That Agreement cured the defects of the court's description and established the correct line between the State's and Orwick's properties. For unexplained reasons, the document languished and was not executed by the Parties.

Charles Orwick has recently approached the Commission to conclude execution of the Agreement. Because of the passage of so much time, staff has decided to bring to the Commission for re-authorization.

The Agreement now executed by Charles Orwick is the same as that drafted in 1987. There have been no changes to its substance aside from allowing each Party to seek a judicial confirmation if either desires to do so. The same line based on the Commission's Map of Survey is incorporated in the document. Staff continues to believe it is in the best interests of the State to have the Agreement approved, executed and recorded.




