12 acres, more or less, of sovereign lands in the Pacific Ocean, near Huntington Beach, Orange County.

## AUTHORIZED USE:

Right of way use for one 24-inch outfall pipeline to route two power cables from shore to Platform Edith and Platform Eva and one six-inch natural gas pipeline between Platform Edith and Platform Eva.

#### LEASE TERM:

25 years, beginning December 1, 1982.

## **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$28,836 per year to \$43,394 per year, effective December 1, 2001.
