Larry Gannon and Patricia Gannon 1229 Blair Road Pollock Pines, CA 95726

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Kings Beach, Placer County.

#### **AUTHORIZED USE:**

Continued use and maintenance of a pier and retention of one existing mooring buoy as shown on the attached Exhibit A.

#### LEASE TERM:

Ten years, beginning July 1, 2001.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$300,000.

Other:

This lease is conditioned on Lessee obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoy within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

#### OTHER PERTINENT INFORMATION:

 The Commission had previously authorized a Recreational Pier Permit with Larry Gannon and Patricia Gannon. That lease has expired. Applicants qualify for a Recreational Pier Lease because they are natural





## **SITE MAP**




EXISTING BUOY
