IN STATE GAS LEASE NO. PRC 714.1, FURTH 1-15 UNIT,  
MELLO 1-10 UNIT, GEORGIANA SLOUGH,  
SACRAMENTO COUNTY**

**AREA, LAND TYPE, AND LOCATION:**

State Gas Lease No. 714.1 (Lease) contains approximately 350 acres of tide and submerged lands in the bed of Georgiana Slough in Sacramento County.

**BACKGROUND:**

State Gas Lease No. PRC 714.1 was entered into on or about April 18, 1952, between the California State Lands Commission (Commission) and the Brazos Oil Company (Lessee). Through a series of assignments and name changes, EOG Resources, Inc. (EOG), became the lessee under the Lease.

On August 26, 1997, the Commission consented to the pooling of a 13.041 acres portion of the lands covered by PRC 714.1 into the "Furth 1-15 Unit" as promulgated under that certain Declaration of Pooling, dated July 1, 1997 (as shown on Exhibit B-1, attached hereto). On December 8, 1998, the Commission

consented to the pooling of a 14.1 acre portion of the lands covered by PRC 714.1 into the "Mello 1-10 Unit" as promulgated under that certain Declaration of Pooling, dated July 1, 1998, (as shown in Exhibit B-2 attached hereto). Each of the units was formed for the development and production of natural gas.

On April 24, 2001, the Commission consented to partial assignment of EOG's 100 percent (100%) interest in Oil and Gas Lease PRC 714.1, insofar and only insofar as said lease covers lands and interests included in the "Furth 1-15 Unit" and the "Mello 1-10 Unit" to Oxy Resources California, LLC. Oxy Resources California, LLC is now requesting that the Commission approve assignment of this same interest in Gas Lease No. PRC 714.1 (insofar and only insofar as said lease covers lands and interest included in the "Furth 1-15 Unit" and the "Mello 1-10 Unit") to Mr. Jim Graham. The "Mello 1-10 Unit" and the "Furth 1-15 Unit" last produced in December 2000. Mr. Graham is planning to return these units to production.

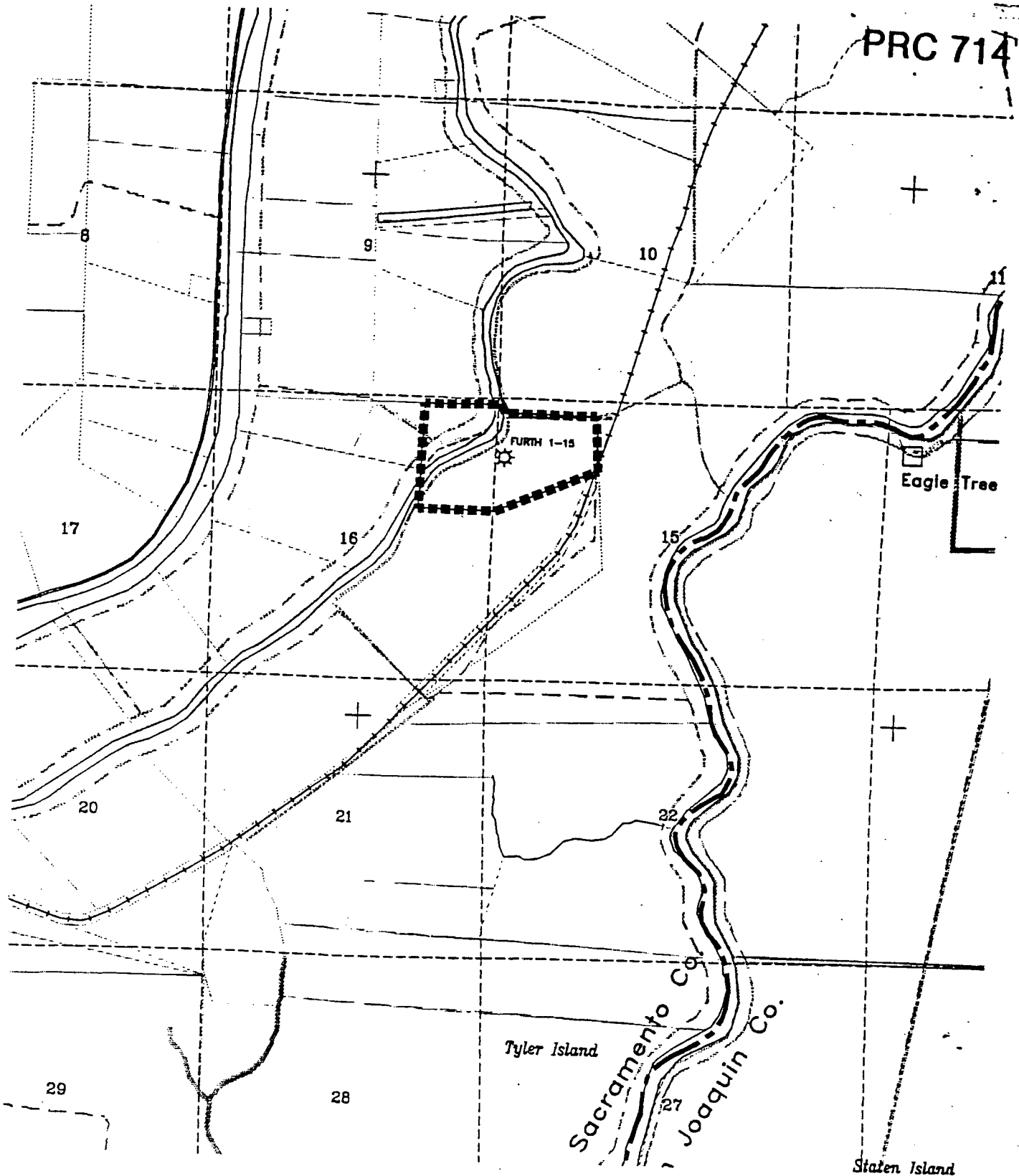

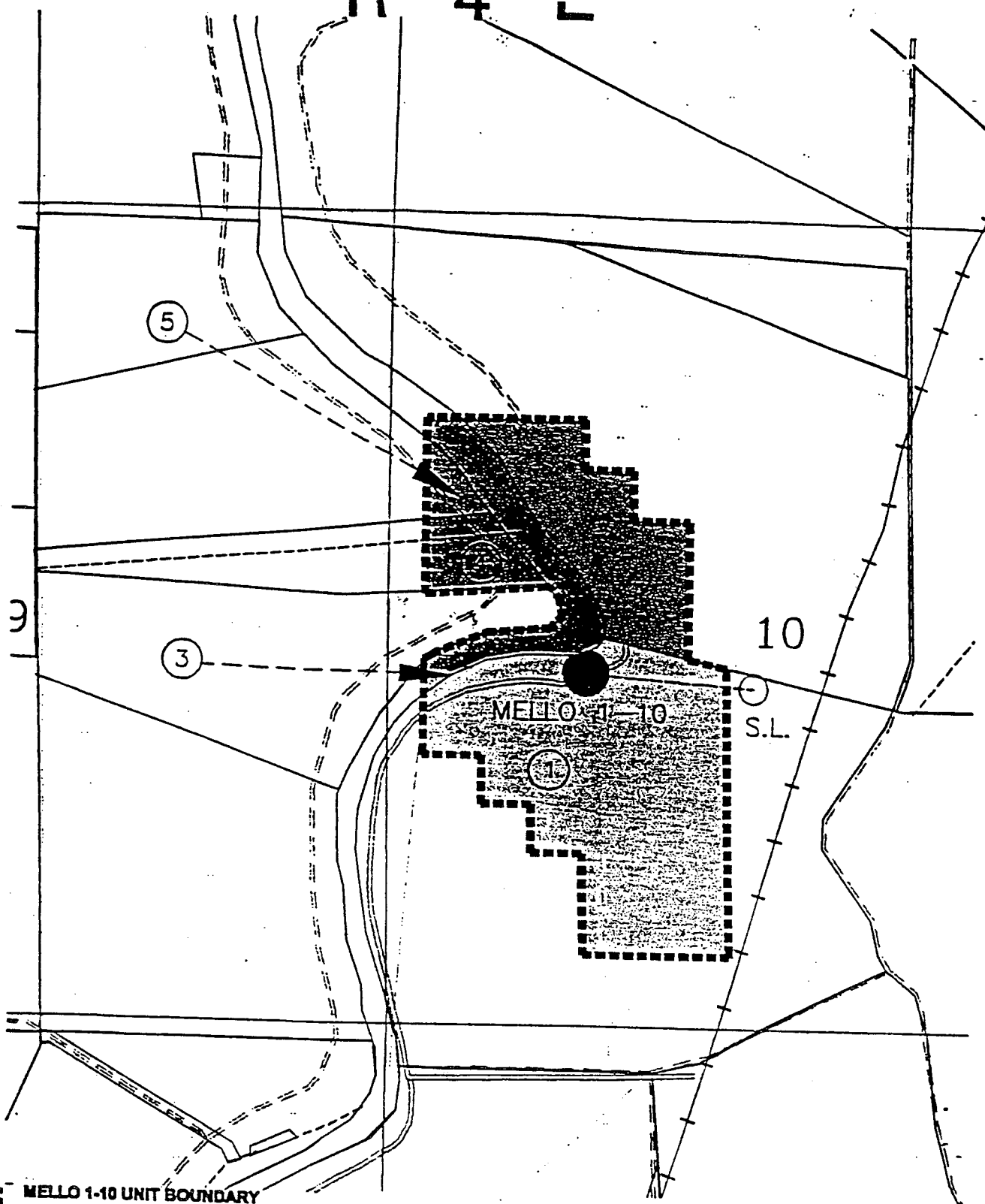
