APPLICANTS:

John S. Frazee, M.D. & Mary Kay Frazee, Trustees of the John S. & Mary Kay Frazee Trust dated April 30, 1992

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, located near the city of South Lake Tahoe, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier previously authorized by the California State Lands Commission.

LEASE TERM:

Ten years, beginning April 1, 2002.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

- 1. On February 6, 1989, the Commission approved the issuance of a Recreational Pier Lease to John Frazee for the existing pier. The Applicants have submitted an application for a new Recreational Pier lease for the existing pier previously authorized by the Commission.
- Applicants qualify for a Recreational Pier Lease because they are natural
 persons who have improved the littoral land with, and use the upland for, a
 single-family dwelling. Applicants are applying for a new Recreational Pier
 Lease.


