# AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Dollar Point, Placer County.

#### **AUTHORIZED USE:**

Retention of two existing mooring buoys as shown on the attached Exhibit A.

# **LEASE TERM:**

Ten years, beginning November 1, 2001.

#### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

#### Other:

This lease is conditioned on Lessee obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

#### OTHER PERTINENT INFORMATION:

1. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Ryan P. Heafey, Matthew W. Heafey, and Alison M. Heafey are now applying for a new Recreational Pier Lease.

2.
