CONTINUATION OF RENT

LESSEE:

San Joaquin Delta Power Squadron
P.O. Box 70155
Stockton, CA 95267

AREA, LAND TYPE, AND LOCATION:

0.35 acres, more or less, of tide and submerged lands in the filled and unfilled bed of the old channel of the San Joaquin River, near Headreach Island, San Joaquin County.

AUTHORIZED USE:

One 2,200 square foot floating dock and ramp; one 812 square foot floating dock comprised of two sections - a 69 foot long by 8 foot wide southern extension and a 52 foot long by 5 foot wide eastern extension; one concrete pad improved with a wooden platform and patio roof, and one concrete pad with barbecue grills; a 250 foot long retaining wall constructed of a 3 inch by 12 inches by 16 inches. Douglas fir supported front and back by a 2 inch galvanized pipe spaced approximately every four feet.

LEASE TERM:

25 years, beginning November 1, 1986.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$1,910 per year, effective November 1, 2002.

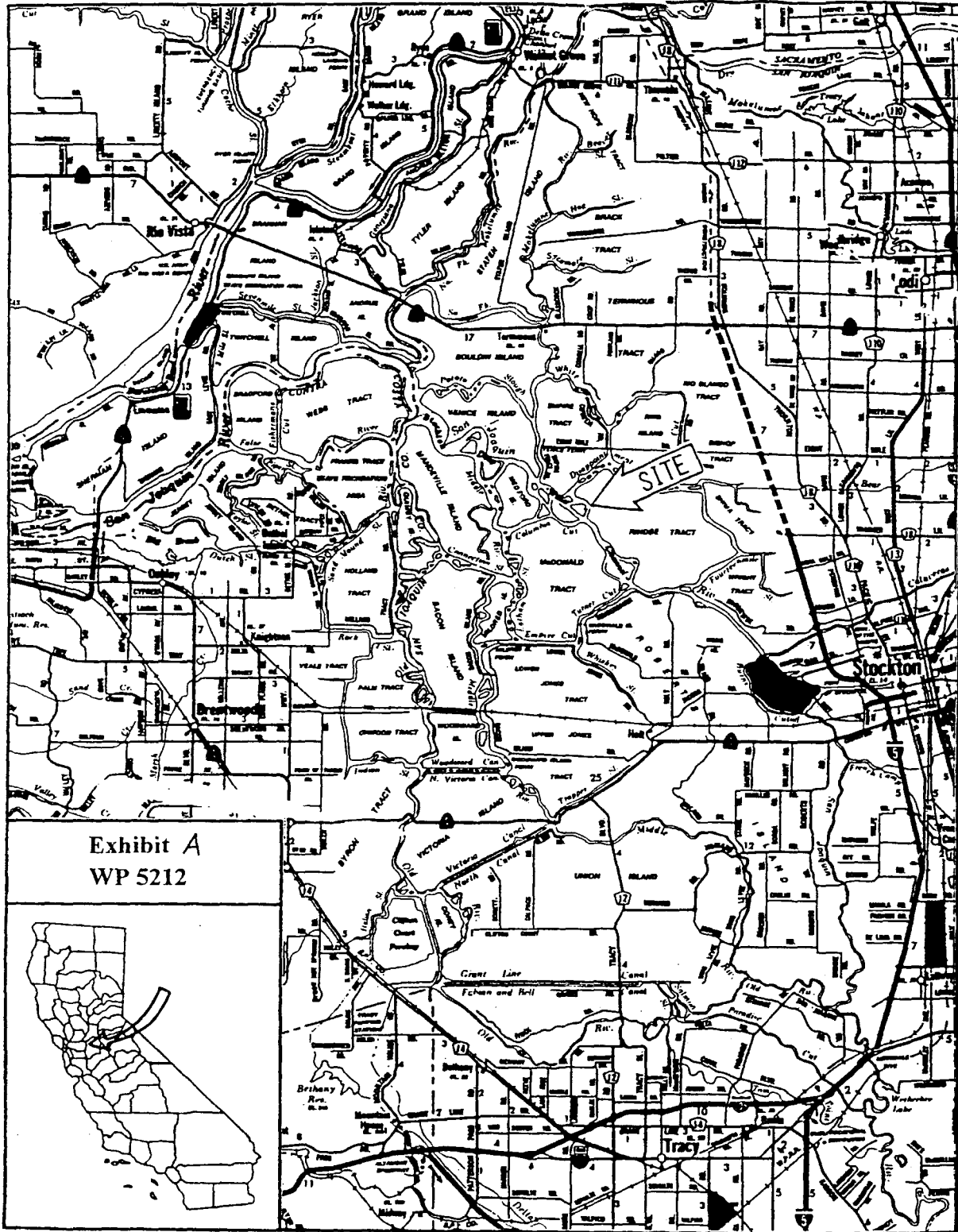
