Sovereign lands in Donner Lake, Truckee, Nevada County.

AUTHORIZED USE:

Construction of a new pier as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning March 1, 2002

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

- 1. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Mark C. Lambert and Mary L. Lambert are now applying for a new Recreational Pier Lease.
