Kent D. Powell and Margaret Jean Powell, Trustees of the Kent and Margaret Powell Family 1985 Revocable Trust, established Jan. 8, 1985

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Donner Lake, near the city of Truckee, Nevada County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning January 8, 2002.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance with coverage of no less than \$300,000.

OTHER PERTINENT INFORMATION:

- 1. On January 8, 1992, the Commission authorized a Recreational Pier Permit to Kent D. Powell and Margaret Jean Powell. The lease expired on January 7, 2002. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Kent D. Powell and Margaret Jean Powell are now applying for a new Recreational Pier Lease.
- 2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the


