**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Thomas G. Wertz and Ursula E. Wertz

**AREA, LAND TYPE, AND LOCATION:**

Tide and submerged lands in Corte Madera Creek, near the city of Larkspur,  
Marin County.

**AUTHORIZED USE:**

Reconstruction, use, and maintenance of an existing ramp and boat dock.

**LEASE TERM:**

Ten years, beginning November 1, 2002.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. On December 17, 1992, the Commission authorized a Recreational Pier Permit with Thomas G. and Ursula Wertz. That lease expired on October 31, 2002. The boat dock and ramp are being reconstructed. Thomas G. Wertz and Ursula E. Wertz are now applying for a new Recreational Pier Lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.

CALENDAR ITEM NO. C10 (CONT'D)

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 2, Replacement and Reconstruction; Title 2, California Code of Regulations, section 2905 (b).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

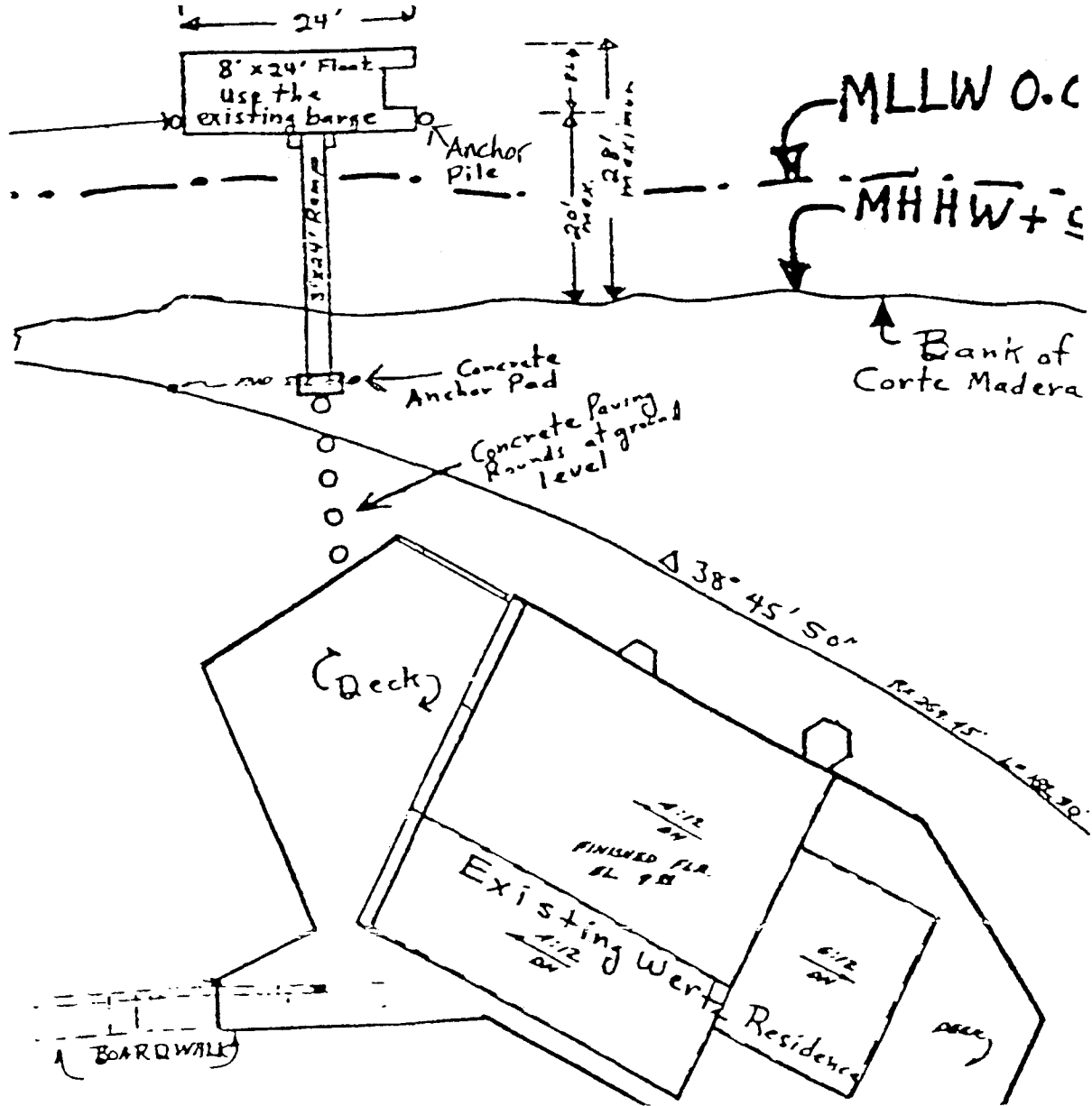

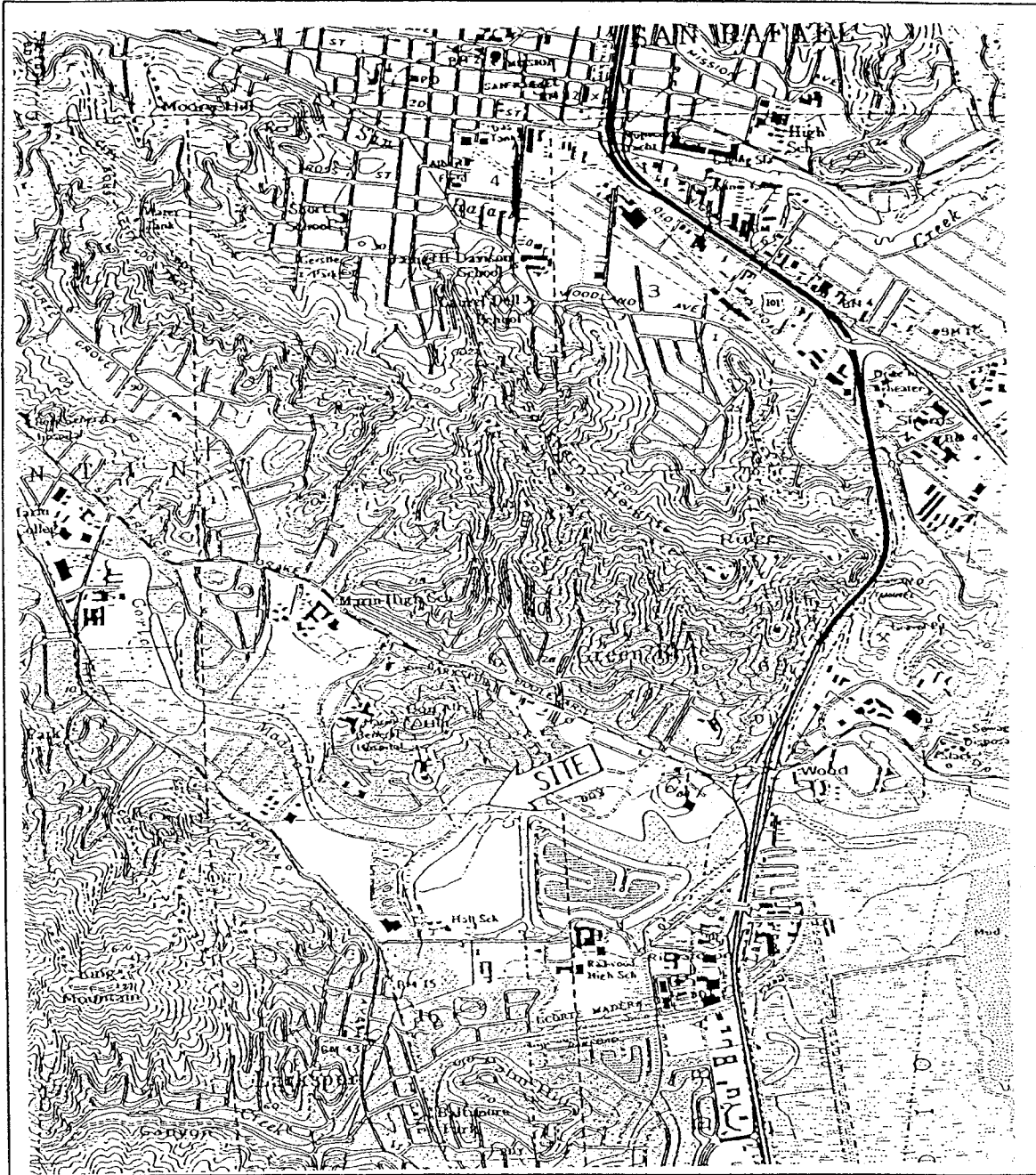
