Sovereign lands in the Calaveras River, city of Stockton, San Joaquin County.

AUTHORIZED USE:

The continued use and maintenance of an existing boat berth and walkway.

LEASE TERM:

Ten years, beginning July 24, 2002.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

On March 3, 1990, the Commission authorized a Recreational Pier Permit 1. with Robert and Starletta Sankus. On July 24, 2002, the littoral land was deeded to Kim Currieri and Lynne Currieri. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.




