**GENERAL LEASE - RECREATIONAL USE**

**LESSEE:**

Sophie S. Olson

**AREA, LAND TYPE, AND LOCATION:**

0.05 acres, more or less, of sovereign lands in the Sacramento River, city of Sacramento, Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing 14-foot by 8-foot floating dock and a 70-foot long suspended walkway.

**LEASE TERM:**

Ten years, beginning July 21, 2001.

**CONSIDERATION:**

\$276.00 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance: Combined single limit coverage of \$500,000.

**OTHER PERTINENT INFORMATION:**

1. Applicant has a right to use the uplands adjoining the lease premises.
2. Applicant does not qualify for a rent-free Recreational Pier Lease because the city of Sacramento owns the upland immediately adjacent to the floating dock and walkway.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the

staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

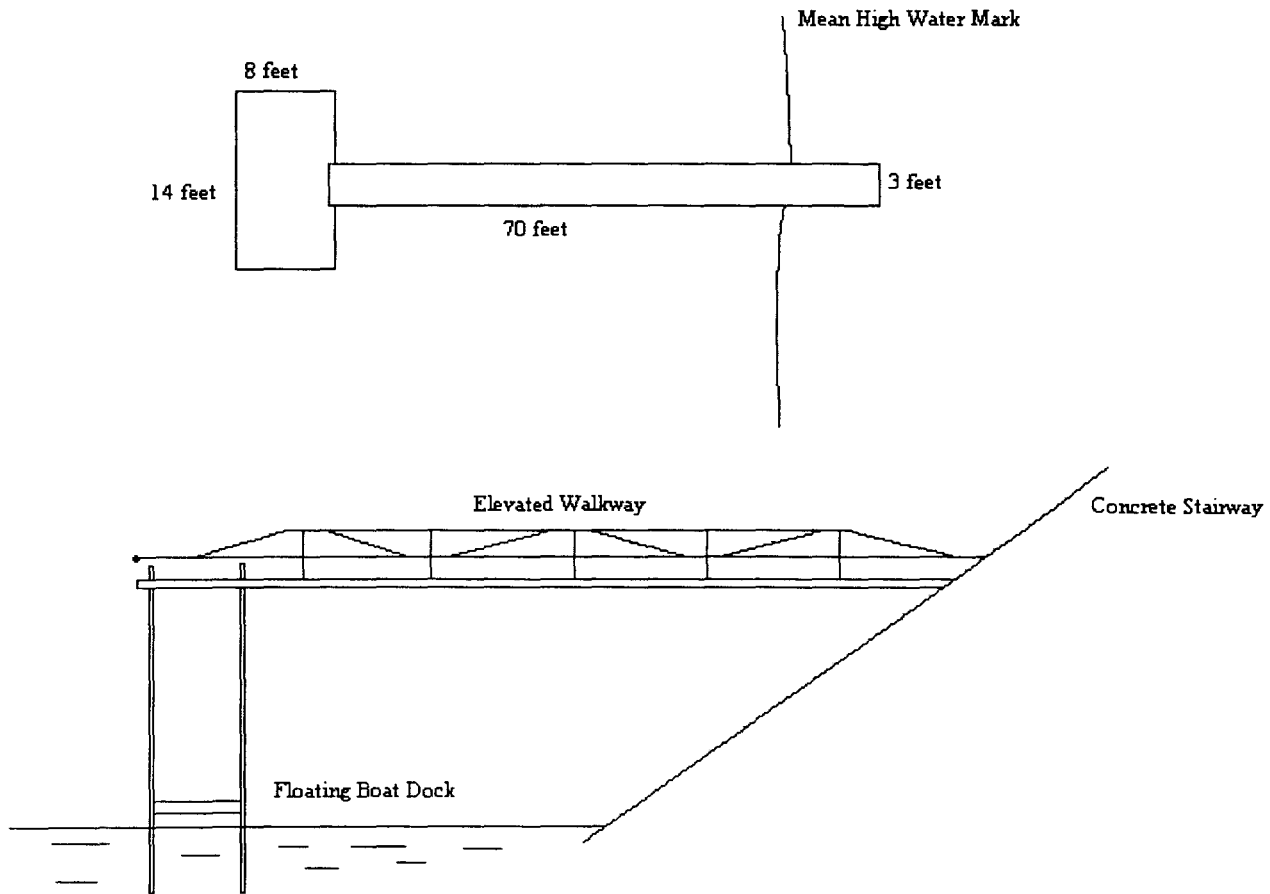

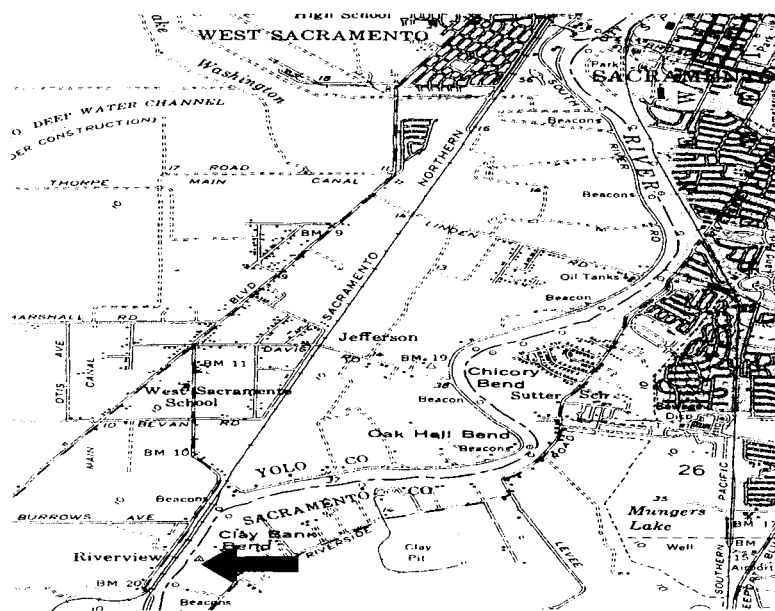
**AUTHORIZATION:**

AUTHORIZE ISSUANCE TO SOPHIE S. OLSON OF A GENERAL LEASE - RECREATIONAL USE, BEGINNING JULY 22, 2001, FOR A TERM OF TEN YEARS, FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING FLOATING BOAT DOCK AND WALKWAY ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$276, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENT IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$500,000.
