**DREDGING LEASE**

**APPLICANT:**

Kiewit Pacific Company  
PO Box 1769  
Vancouver, WA 98668

**AREA, LAND TYPE, AND LOCATION:**

Granted sovereign lands, with minerals reserved to the State, and ungranted sovereign lands at the north end of the Vallejo Waterfront, Mare Island Strait (Napa River), city of Vallejo, Solano County.

**AUTHORIZED USE:**

Maintenance dredge a maximum of 4,400 cubic yards of material annually to maintain a navigational channel. Deposition of dredge materials at the United States Army Corps of Engineers approved Carquinez Strait Site (SF-9).

**LEASE TERM:**

10 years, beginning February 1, 2003.

**CONSIDERATION:**

No royalty will be charged for aquatic disposal; \$0.25 per cubic yard will be charged for any material used for private benefit or for commercial sale purposes.

**OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061). The staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that the CEQA applies only to projects, which have the potential for causing a significant effect on the environment. The staff believes, based on the information available to it, that there is no possibility that this project

may have a significant effect on the environment. Authority: Title 14, California Code of Regulations, section 15061 (b)(3).

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

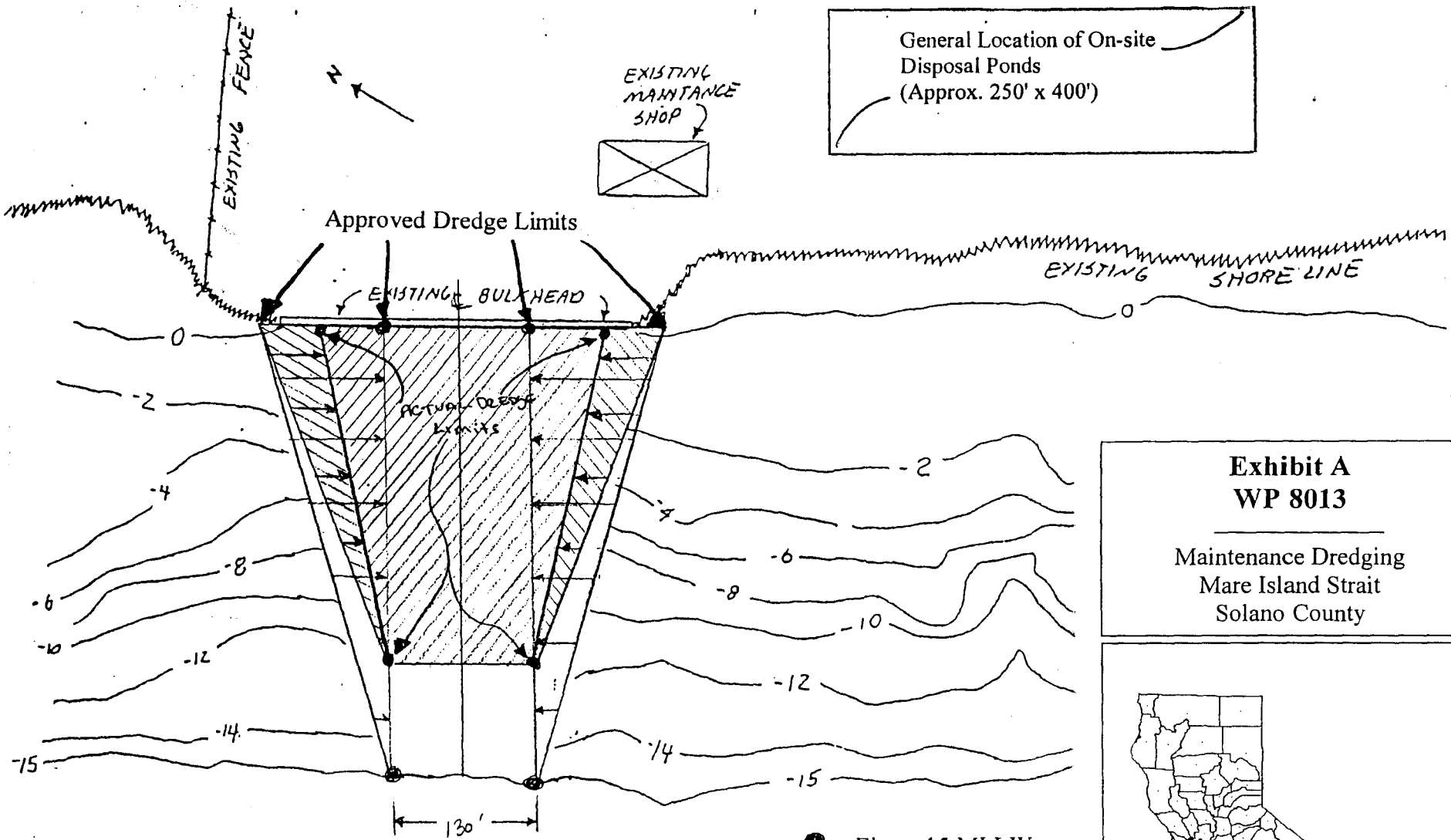
**AUTHORIZATION:**

MAXIMUM OF 4,400 CUBIC YARDS OF MATERIAL ANNUALLY AT THE NORTH END OF THE VALLEJO WATERFRONT, MARE ISLAND STRAIT AS SHOWN ON EXHIBIT A, ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENTS. NO ROYALTY SHALL BE CHARGED FOR DISPOSAL OF DREDGED MATERIAL; \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR ANY MATERIAL USED FOR PRIVATE BENEFIT OR COMMERCIAL SALE PURPOSES.

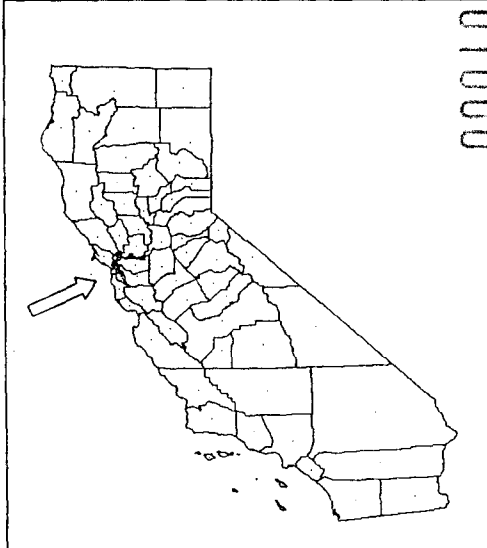
