### **REVISION OF RENT**

### LESSEE:

Dollar Point Subdivision Homeowners Association P. O. Box 1490 Tahoe City, CA 96145

### AREA, LAND TYPE, AND LOCATION:

3.1 acres, more or less, of sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier, swim area, 63 mooring buoys and two U. S. Coast Guard marker buoys.

### LEASE TERM:

Ten years, beginning September 1, 1997.

### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$797 per year to \$2,366 per year, effective September 1, 2003.

### OTHER PERTINENT INFORMATION:

1. The Commission authorized a General Lease-Recreational Use to Dollar Point Subdivision Homeowners Association. The annual rent for the lease is based on the number of member owners that are natural persons and qualify for "rent-free" status pursuant to Section 6503.5 of the Public Resource Code. The two marker buoys and swim area do not qualify for "rent-free" status.




