DREDGING LEASE

APPLICANT:

City of Vallejo
P.O. Box 3068
Vallejo, CA 94590

AREA, LAND TYPE, AND LOCATION:

Legislatively granted sovereign lands with minerals reserved to the State; and ungranted sovereign land located in Mare Island Strait at the Vallejo Municipal Marina – South Harbor, city of Vallejo, Solano County.

AUTHORIZED USE:

Dredge a maximum of 92,500 cubic yards of material over three years to maintain a navigable depth. Dredged materials will be disposed of at United States Corps of Engineers designated disposal site SF-9 (Carquinez Strait).

LEASE TERM:

Three years, beginning September 2003.

CONSIDERATION:

No royalty will be charged; \$0.25 per cubic yard will be charged for any material used for private benefit or commercial sale purposes.

OTHER PERTINENT INFORMATION:

1. On April 20, 2000, the Commission authorized the City of Vallejo to conduct maintenance dredging within granted sovereign lands with minerals reserved in the Vallejo Municipal Marina's North Harbor for a period of five years, beginning May 1, 2000, allowing the removal of a maximum of 170, 804 cubic yards of material to maintain a navigable depth. The Commission authorized this activity after determining it to be categorically exempt from CEQA

under Class 4, Minor Alterations to Land; Title 14, California Code of Regulations, section 15304 (g).

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land; Title 14, California Code of Regulations, section 15304 (g).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

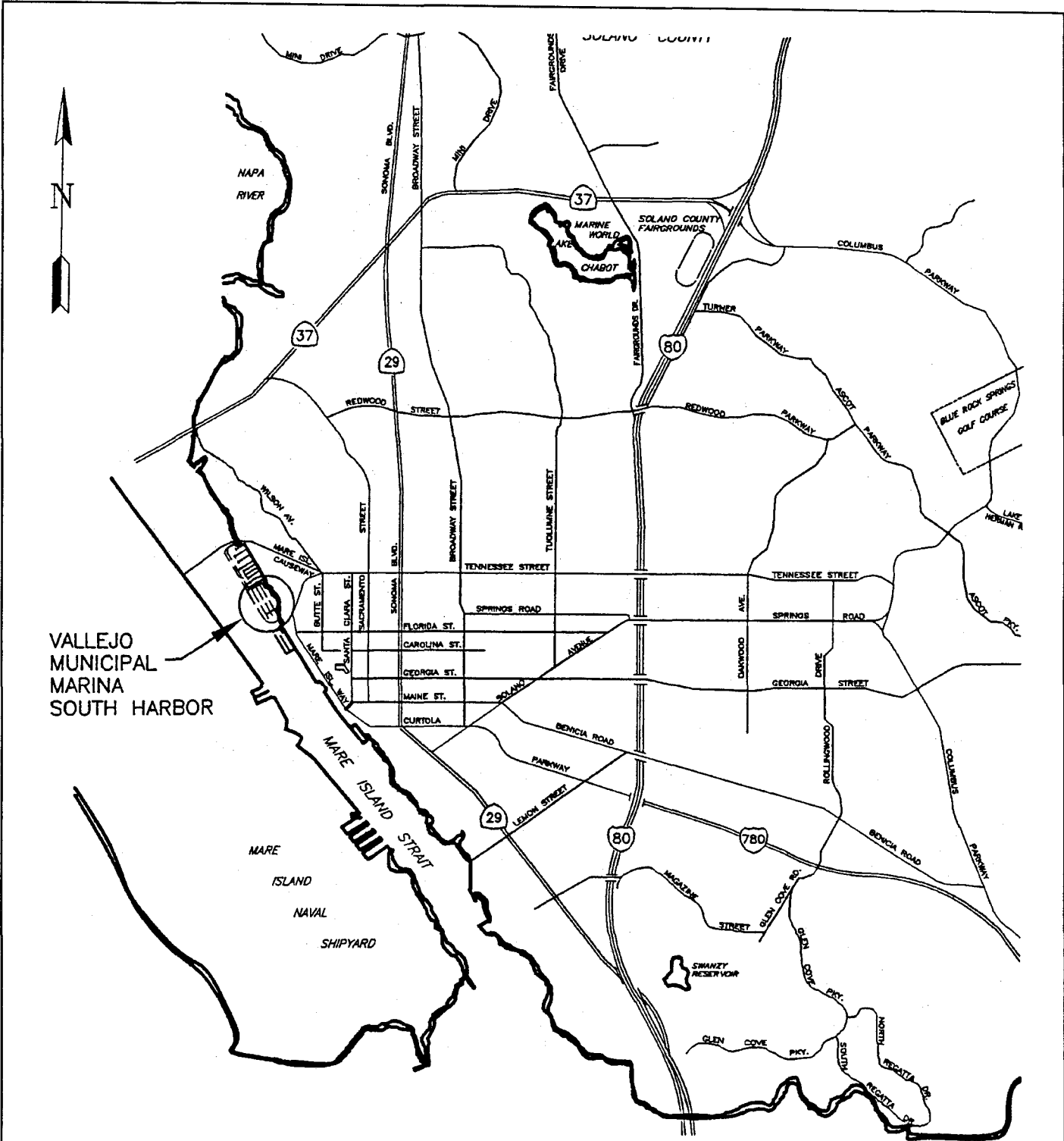

SIGNIFICANT LANDS INVENTORY FINDING:

FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED BY THE COMMISSION FOR THE LAND PURSUANT TO PUBLIC RESOURCES CODE SECTIONS 6370, ET SEQ.

AUTHORIZATION:

AUTHORIZE THE ISSUANCE OF A DREDGING LEASE TO THE CITY OF VALLEJO, BEGINNING SEPTEMBER 2003, AND EXTENDING THROUGH SEPTEMBER 1, 2006, FOR DREDGING A MAXIMUM OF 92,500 CUBIC YARDS OF MATERIAL FROM THE MARE ISLAND STRAIT AS SHOWN ON EXHIBITS A AND B ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF. DREDGED MATERIALS WILL BE DISPOSED OF AT THE U.S ARMY CORPS OF ENGINEERS DESIGNATED DISPOSAL SITE SF-9 (CARQUINEZ STRAIT). SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENTS. NO ROYALTY SHALL BE CHARGED, AS THE PROJECT WILL RESULT IN A PUBLIC BENEFIT; \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR ANY MATERIAL USED FOR PRIVATE BENEFIT OR FOR COMMERCIAL SALE PURPOSES.



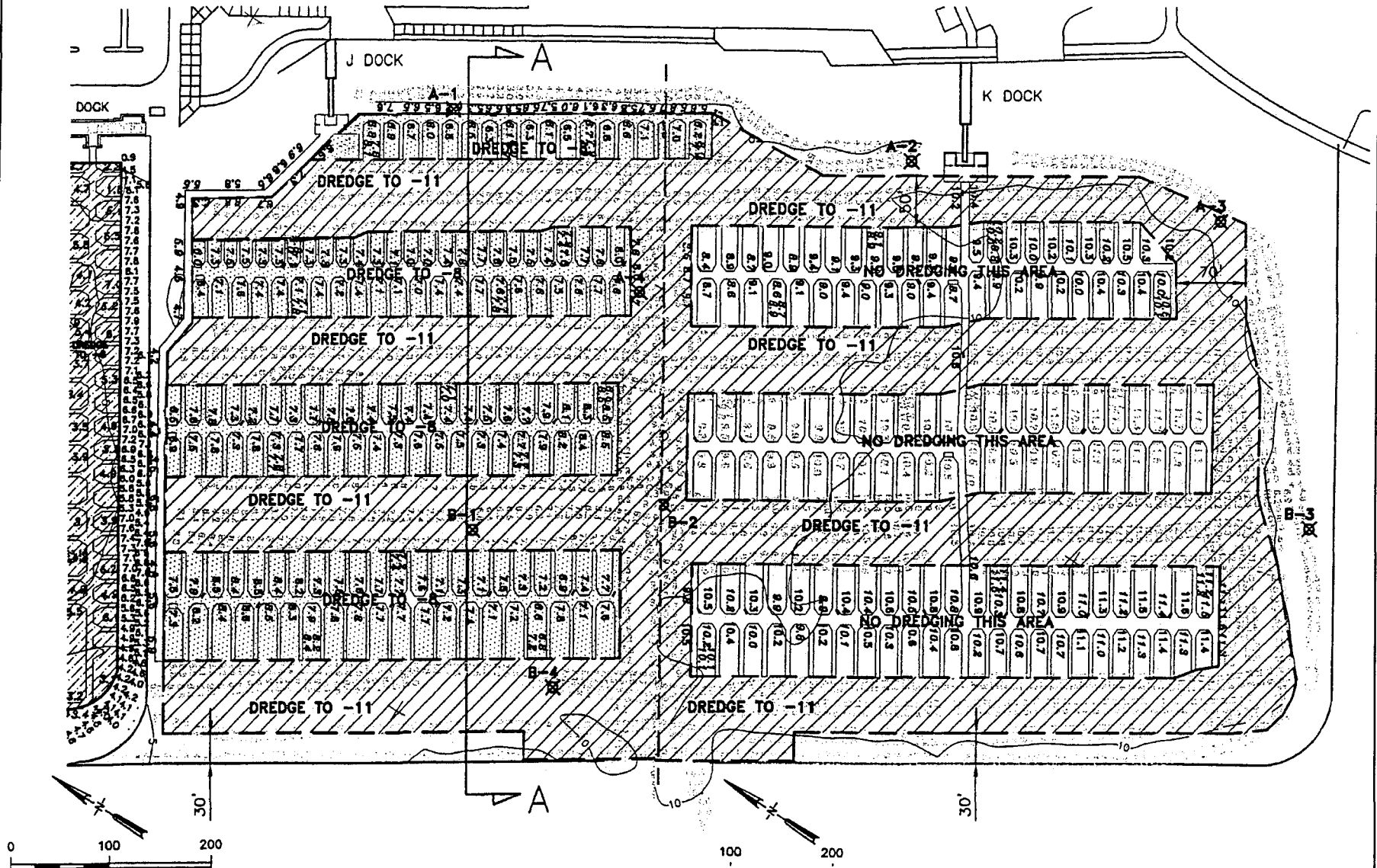
