#### RECREATIONAL PIER LEASE

### **APPLICANTS:**

Lowell W. Lash and Terry L. Lash

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Tahoe City, Placer County.

#### **AUTHORIZED USE:**

Retention of two mooring buoys as shown on the attached Exhibit A.

#### **LEASE TERM:**

Ten years, beginning April 1, 2004.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### **SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

This lease is conditioned on the Applicants obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

#### OTHER PERTINENT INFORMATION:

- 1. Applicants own the upland property adjoining the lease premises.
- 2. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling. Applicants are now applying for the retention of two mooring buoys, not previously authorized by the Commission.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(3).

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. 




