The Gar Wood Building, A California Limited Partnership P. O. Box 1133 Carnelian Bay, CA 96140-1133

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a restaurant accommodation pier, 14 mooring buoys and three marker buoys, as shown on Exhibit A.

LEASE TERM:

Ten years, beginning June 1, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$2,403 per year, effective June 1, 2004.

OTHER PERTINANT INFORMATION:

1. Lessee owns the upland property, which is improved with a restaurant and adjacent parking lot. The public and customers of the restaurant use the pier and the restaurant operates a free shuttle to pick up boaters using the mooring buoys. There is no overnight use of the mooring buoys. The pier and mooring buoys are non-revenue generating with no charge for any uses. The public has additional access to the pier from the adjacent Lake Tahoe Conservancy development and public parking lot.






