CONSIDER ACCEPTANCE OF FULL QUITCLAIM DEED FOR STATE OIL AND GAS LEASE NO. PRC 2879.1, (5,653.1 ACRES OFFSHORE POINT CONCEPTION AND GOVERNMENT POINT), SANTA BARBARA COUNTY

AREA, LAND TYPE, AND LOCATION:

Oil and Gas Lease No. PRC 2879.1 (Lease) contains approximately 5,653.1 acres of tide and submerged lands located offshore and south of Point Conception and Government Point in Santa Barbara County, California.

BACKGROUND:

The Lease was issued by competitive bid to Union Oil Company of California on April 26, 1962, for the cash bonus payment of \$3,047,740.00. The rental is \$5,653.10 or \$1.00 per acre per year. For the period 1964 to 1992, the leased lands produced about 1.191 million barrels of oil and 643 MMcf of gas from nine wells directionally drilled from onshore locations into the northern portion of the leased lands. These wells were plugged and abandoned and the Point Conception Field abandoned in 1994. Additionally, there were six exploratory wells drilled into the leased lands from offshore drill vessels that were never connected to shore nor produced. The offshore wells were abandoned and removed as part of the SWARS (Subsea Well Abandonment and Rig Sharing) program in or around 1997.

The Cojo Field (in the southern portion of the lease and overlapping into "Parcel 1" to the west) is estimated by staff to still contain 150 million barrels of recoverable oil within State waters.

000640 MINUTE PAGE In the mid-1980s, the Lessee submitted an application to develop the untapped reserves on the Lease. The original proposal was to install a 48-slot platform (named Haley) in 285 feet of water about 2.75 miles offshore Point Conception. In 1988, an EIR had been prepared for the project and the final draft was being reviewed, however the matter was not presented to the Commission because the applicant elected to withdraw its application. Later that year, Unocal had discussions with Commission staff, exploring the possibility of developing the reserves by "long-reach" directional drilling from existing shore-based facilities. That proposal was not pursued and did not develop into a formal application because only a limited number of wells were considered which Commission staff determined would be insufficient to adequately develop the reservoir. Unocal did not submit any further applications for additional exploration or development of the lease.

Public Resources Code Section 6804.1 and Lease Paragraph 5 permit the Lessee at any time to make and file with the Commission a written quitclaim of all rights under the Lease. The quitclaim will be effective as of the date of its filing, subject to its acceptance by the Commission. On April 16, 2003, Commission staff received from the Lessee the document "Lease Quitclaim Deed for State Oil and Gas Lease" (Exhibit C, attached hereto). This document is dated April 2, 2003, and quitclaims back to the State all of the Lessee's interest in the Lease. A review of the Commission's files reveals that no default exists on the Lease, that the Lessee has complied with all applicable laws and Lease provisions, and has paid all rentals.


