**REVISION OF RENT**

**LESSEE:**

Bodega Farms  
Box 6886  
San Rafael, CA 94903

**AREA, LAND TYPE, AND LOCATION:**

.02 acre of tide and submerged land in Estero Americano and .46 acre of tide and submerged land near Bodega Bay, Sonoma County.

**AUTHORIZED USE:**

Continued maintenance and use of one 12-inch diameter polyethylene saltwater intake pipeline at Estero Americano, one 8-inch diameter polyethylene saltwater intake pipeline, and one 8-inch diameter polyethylene outfall in the Pacific Ocean to support an onshore fish farm facility.

**LEASE TERM:**

15 years, beginning August 1, 1994.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$124.00 per year to \$167.00 per year, effective August 1, 2004.

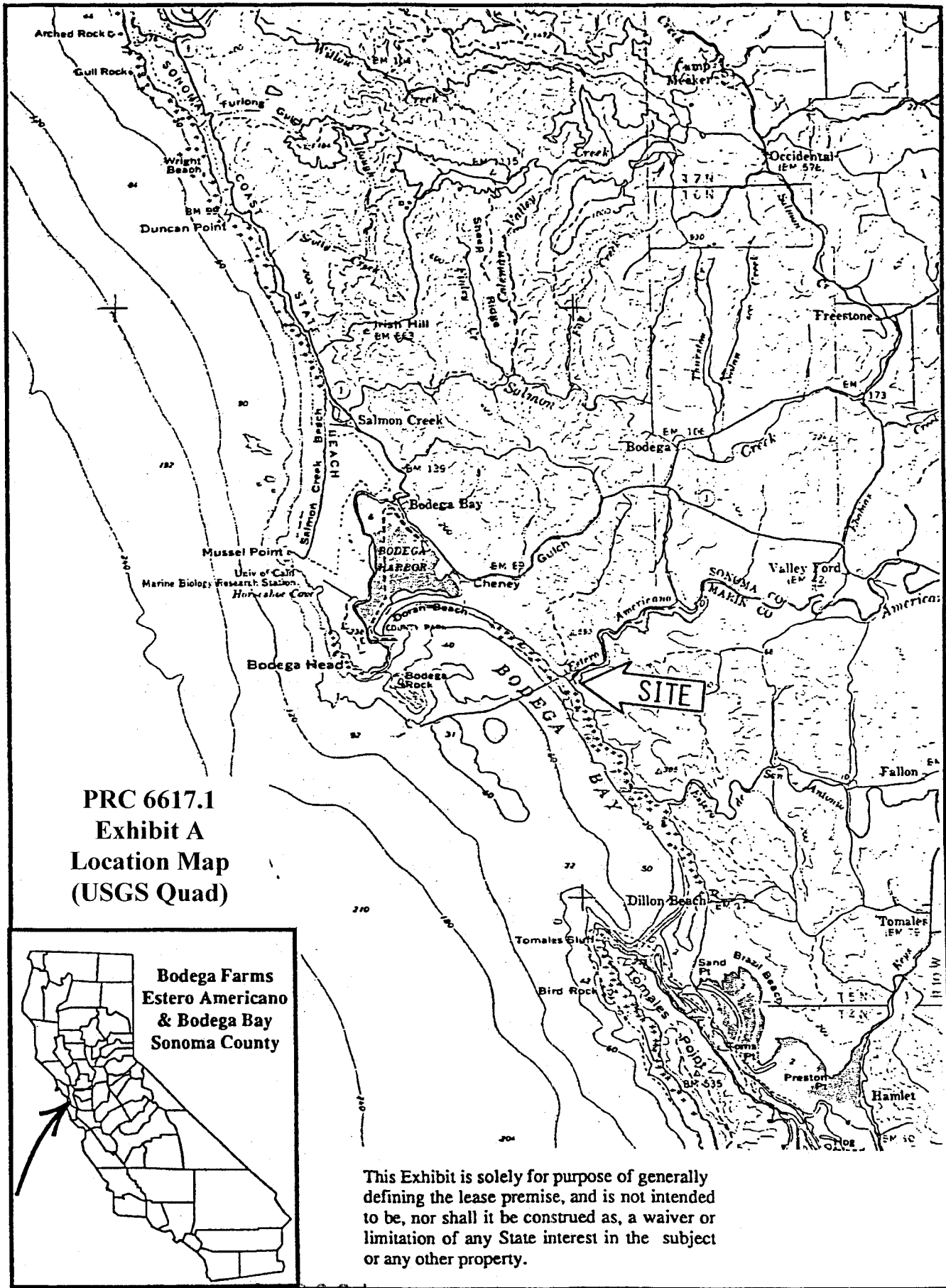

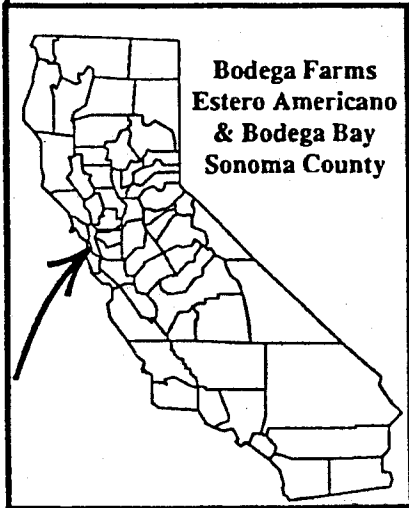
