# RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF JUNE 7, 2004

Calendar Items C54 and C55 were removed from the agenda to be heard at a subsequent meeting.

The recommendation of staff, relative to Calendar Items C01-C48, C50-C53, C56 and C57 were approved by unanimous vote of Commission Chair Steve Westly and Commission Alternate, Lorena Gonzalez. The Department of Finance was not represented at the meeting.

Consent Calendar Item 49: Consideration of purchasing a temporary easement from Hearthside Residential Corp. The item was approved with the other consent items but the Executive Officer orally amended the cap from \$250,000 to \$75,000.

**Regular Item 58:** Commissioners listened to staff report on certification of an EIR and revised removal project called Bird Island. The item was approved as presented with a 2-0 **v**ote.

**Regular Item 59:** Commissioners listened to presentation by Executive Officer pertaining to a resolution supporting the Pew Commission and the U.S. Ocean Commission reports. The **C**ommission adopted the resolution by a 2-0 vote.

**Regular Item 60:** Executive Officer made presentation to the Commission regarding a resolution pertaining to the Commission's continued opposition to drilling in federal oil and gas leases along the California coast. The item was approved as presented by a 2-0 vote.
