**CONTINUATION OF RENT**

**LESSEE:**

David and Carol Burkhart

**AREA, LAND TYPE, AND LOCATION:**

0.03 acres, more or less, of sovereign lands in the Petaluma River, near  
Lakeville, Sonoma County.

**AUTHORIZED USE:**

Continued use and maintenance of a walkway, a boathouse, a deck, and a boat  
dock.

**LEASE TERM:**

Ten years, beginning July 1, 1999.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease  
term. Pursuant to this provision, staff has conducted a review of the rent under  
this lease, and recommends that rent be continued at \$170 per year, effective  
July 1, 2004.

**OTHER PERTINENT INFORMATION:**

On December 12, 1999, the Commission authorized a General Lease –  
Recreational Use to David Burkhart and Carol Burkhart for the continued use and  
maintenance of a walkway, a boathouse, a deck, and a boat dock. The Lessee  
has the right to use the uplands adjoining the lease premises, located in the  
Petaluma River, near Lakeville, in Sonoma County.

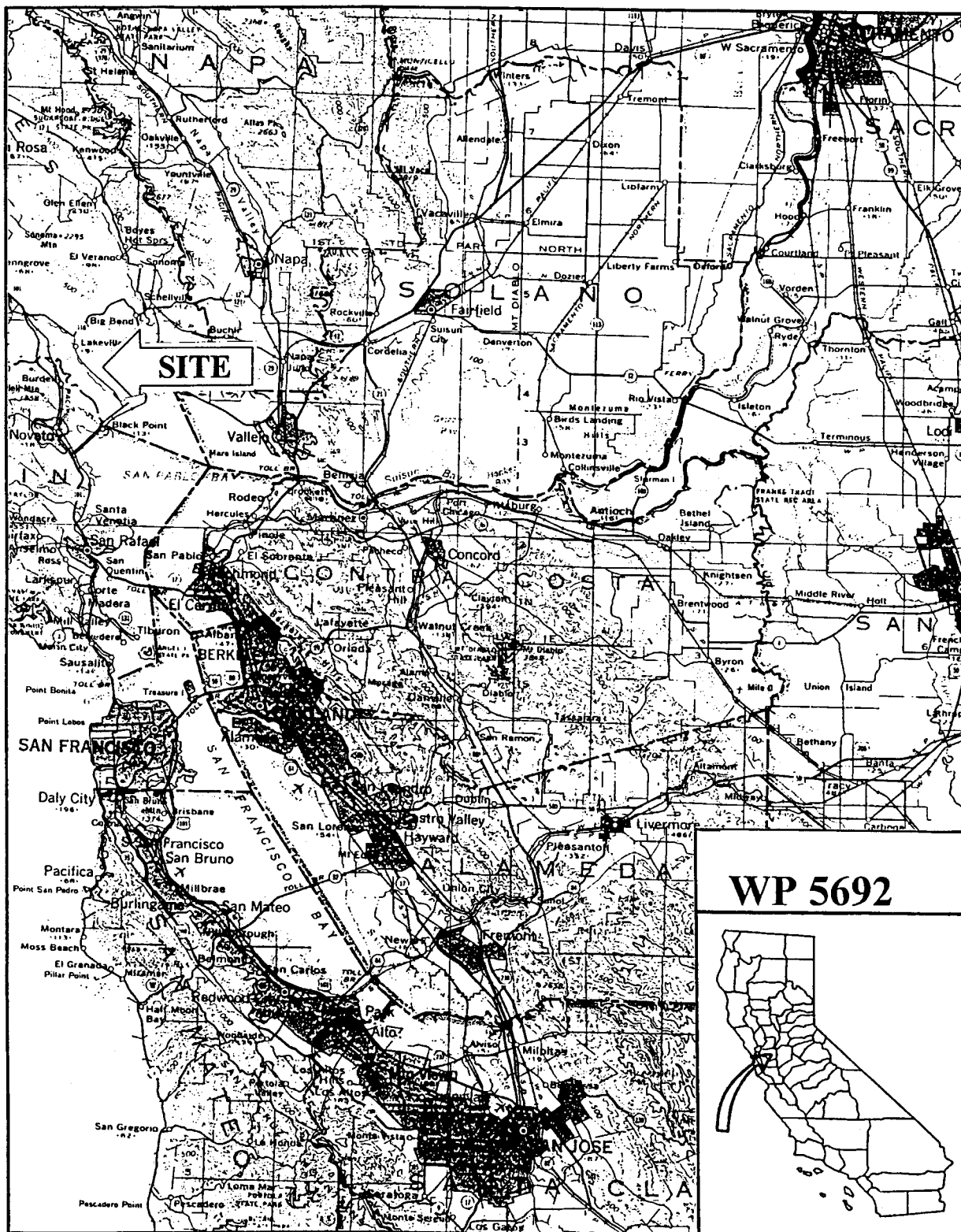
