GENERAL LEASE-RIGHT OF WAY USE

APPLICANT:

Leland Rock 56157 Highway 101 Fortuna, CA 95540

AREA, LAND TYPE, AND LOCATION:

0.05 acres more or less, of sovereign lands in the Van Duzen River, near Alton, Humboldt County.

AUTHORIZED USE:

Placement, use, maintenance and removal of seasonal bridge crossing (s), previously authorized by the Commission as shown on Exhibit A.

LEASE TERM:

Beginning September 9, 2004, and expiring on October 15, 2009.

CONSIDERATION:

\$100 per annum; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- Applicant owns the uplands adjoining the lease premises.
- 2. On August 26, 1997, the Commission authorized the issuance of a General Lease Right of Way Use, PRC 7989.1, for the placement of seasonal bridge crossing(s) over the Van Duzen River. That lease expired on August 25, 2002. The rent was paid to date at the time the lease expired.

- 3. In 2001, the Applicant submitted an application to renew the lease; however, was unable to proceed during the timeframe between the 2002 lease expiration date and the present due to ongoing federal consultation on threatened salmonid species in the Eel and Van Duzen Rivers. On August 13, 2004, the National Oceanic and Atmospheric Administration (NOAA) Fisheries published a new biological opinion addressing the new five-year Letter of Permission (LOP) to be issued by the U. S. Army Corps of Engineers for gravel extraction projects. The new biological opinion found that the activities that would be authorized under the LOP are not likely to jeopardize the continued existence of the threatened salmonid species or result in the destruction or adverse modification of coho salmon designated critical habitat. The Applicant is now applying for a new lease for the placement, use, maintenance and removal of annual seasonal bridge crossing(s), within the lands as depicted on Exhibit A.
- 4. The seasonal bridge crossing(s) will be installed, annually, on an asneeded basis, in the summer low flow channel of the Van Duzen riverbed, using two railroad flat cars each; no earlier than June 30 and removal no later than October 15. Trucks and equipment use the bridge crossings during permitted gravel extraction activities in the area. The bridge(s) will be installed with sufficient clearance to provide safe passage for navigation and recreational activities. Low bridge warning signs will be placed while the crossing is in place.
- 5. On September 9, 2004, the California Coastal Commission (CCC) granted Permit # 1-04-045 for this project under its certified regulatory program (Title 14, California Code of Regulations, section 15251 (c)).
- 6. Staff has reviewed the document and determined that the conditions, as specified in Title 14, California Code of Regulations, section 15253 (b), have been met for the Commission to use the environmental analysis document certified by the CCC as a Negative Declaration equivalent in order to comply with the requirements of the CEQA.
- 7. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




