GENERAL LEASE - RIGHT OF WAY USE

APPLICANT:

Mercer, Fraser Company P.O. Box 1006 Eureka, CA 95501-1006

AREA, LAND TYPE, AND LOCATION:

0.194 acres, more or less, of sovereign lands in the Eel River, near Fortuna, Humboldt County.

AUTHORIZED USE:

Annual placement and removal of a temporary seasonal bridge crossing of the Eel River.

LEASE TERM:

Five years, beginning September 9, 2004

CONSIDERATION:

\$100 per annum, with the State reserving the right to fix a different rental periodically during the lease term.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of \$1,000,000.

OTHER PERTINENT INFORMATION:

On April 6, 1994, the Commission approved a ten-year lease, No. PRC 7760.1, issued to Canevari Timber Company for seasonal placement of a flatcar bridge and approaches at the project location in the bed of the Eel River near Fortuna. The purpose of the bridge is to facilitate truck crossings of a low-flow channel utilized to access seasonal extraction of sand and gravel from river bars next to the Eel River. On May 31, 1996, Canevari Timber Company leased the upland parcel to the Applicant,

Mercer, Fraser Company. PRC 7760.1 expired on April 5, 2004 and Mercer, Fraser Company is now applying for a new lease.

- 2. On August 13, 2004, the National Marine Fisheries Service (NOAA Fisheries) published a new biological opinion addressing the new five-year Letter of Permission (LOP) to be issued by the U.S. Army Corps for gravel extraction projects. The new biological opinion found that the activities that would be authorized under the LOP are not likely to jeopardize the continued existence of the threatened salmonid species or result in the destruction or adverse modification of Coho salmon designated critical habitat. Standards limiting the construction of the abutments for bridges and encroachment into the wetted channel are detailed within NOAA Fisheries Biological Opinion for this project.
- 3. The seasonal bridge crossing shall only be placed in the summer low flow channel of the Eel River bed after June 30 of each year and be removed by October 15th. Trucks and equipment use the bridge crossing during permitted gravel extraction activities in the area. The bridge will be installed with sufficient clearance to provide safe passage for navigation and recreational activities.
- 4. On September 9, 2004, the California Coastal Commission (CCC) granted Permit No. 1-04-20 for this project under its certified regulatory program (Title 14, California Code of Regulations, Section 15251 (c)).
- 5. Staff has reviewed the document and determined that the conditions, as specified in Title 14, California Code of Regulations, section 15253 (b), have been met for the Commission to use the environmental analysis document certified by the CCC as a Negative Declaration equivalent in order to comply with the requirements of CEQA.
- 6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
