TERMINATION OF GENERAL LEASE PROTECTIVE STRUCTURE AND RECREATIONAL USE; AND ISSUANCE OF GENERAL LEASE PROTECTIVE STRUCTURE AND RECREATIONAL USE

APPLICANTS:

William F. Schaber and Susan M. Schaber

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Georgiana Slough, near the city of Isleton, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of an existing double berth boat dock with boatlift, floating dock, ramp, and bank protection.

LEASE TERM:

Ten years, beginning October 1, 2004.

CONSIDERATION:

Double Berth Boat Dock with boatlift, Floating Dock, and Ramp - No monetary consideration pursuant to Public Resources Code section 6503.5.

Bank Protection – The public use and benefit; with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Combined single limit coverage of no less than \$500,000.

OTHER PERTINENT INFORMATION:

1. Applicants own the uplands adjoining the lease premises.

- 2. On February 27, 1998, the Commission authorized a General Lease Protective Structure and Recreational Use with Gale Leatherman. That lease will expire on October 31, 2007. The property was subsequently transferred to William F. Schaber and Susan M. Schaber. William F. Schaber and Susan M. Schaber have requested a new General Lease – Protective Structure and Recreational Use. Applicants qualify for a rentfree double berth boat dock, floating dock and ramp because the applicants are natural persons who have improved the littoral land with, and use the upland, for a single-family dwelling. The existing lease is being terminated effective September 30, 2004, and the new lease will begin effective October 1, 2004.
- 3. The bank protection at this location mutually benefits both the public and the applicant. The bank of the slough will have the additional protection from wave action provided at no cost to the public.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905(a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission has declared that all tide and submerged lands are "significant" by nature of their public ownership (as opposed to "environmentally significant"). Since such declaration of significance is not based upon the requirements and criteria of Public Resources Code sections 6370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by Title 2, California Code of Regulations, and Section 2954 is not applicable.
