GENERAL LEASE - INDUSTRIAL USE

LESSEE:

Cabrillo Power I LLC 4600 Carlsbad Boulevard Carlsbad, California 92008

AREA, LAND TYPE, AND LOCATION:

102 acres, more or less, of sovereign lands in the Pacific Ocean, Carlsbad, San Diego County.

AUTHORIZED USE:

Placement of suitable dredge material from Agua Hedionda Lagoon on sovereign lands adjacent to Carlsbad State Beach.

LEASE TERM:

Ten years, beginning September 1, 2004.

CONSIDERATION:

\$300 per year; plus the public benefit, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. The Lessee is owner or permittee of the uplands adjoining the lease premises.
- 2. The Lessee, Cabrillo Power I LLC, is requesting a new lease to allow the placement of suitable dredge material from Agua Hedionda Lagoon on sovereign lands adjacent to Carlsbad State Beach. Agua Hedionda Lagoon provides cooling water for the Encina Power Station. It is

necessary for the Lessee to periodically dredge Agua Hedionda Lagoon to maintain the tidal prism necessary to provide adequate seawater for cooling purposes.

A nominal annual rent is justified by the enhancement of Carlsbad State Beach and to downcoast beach areas by sand replenishment through the littoral process.

The Commission first issued Lease No. PRC 932 to San Diego Gas & Electric Company (SDG&E) to perform this ongoing activity in 1954. In 1999, SDG&E sold the upland power facilities to Cabrillo Power I LLC. On April 13, 1999, the Commission authorized the assignment of Lease No. PRC 932, along with other leases associated with the Encina Power Station, to the current Lessee. Lease PRC 932 expired August 31, 2004, and the Lessee has submitted an application for a new lease.

The material will be placed on Carlsbad State Beach as follows: 30% on the beach north of the jetty and 70% on the Middle and South Beaches. Placement of the material will occur outside of the summer season (Memorial Day through Labor Day) in order to avoid impacts to recreation.

To avoid potential impacts to the California Least Tern and the grunion, dredging of the Lagoon will occur between September 15 and April 15, with the option to extend the dredge period to April 30, if approved in writing by the California Coastal Commission (CCC), in consultation with the Corps of Engineers and the Department of Fish and Game (DFG).

The Lessee is also required by the CCC to undertake a survey of the dredge area (including a buffer area at least ten meters beyond the project area) to determine the presence of the invasive alga *Caulerpa taxifolia*. The survey protocol will be prepared in consultation with the Regional Water Quality Control Board, the DFG and the NOAA Fisheries. If the alga is found, the Lessee must notify the DFG and NOAA Fisheries within 24 hours, and the Executive Director of the CCC must subsequently provide written approval either that the alga has been eradicated or that the project has been revised to avoid any contact with the alga.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of

the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 14, California Code of Regulations, section 15304 (g).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


