## RECORD OF ACTION TAKEN BY THE CALIFORNIA STATE LANDS COMMISSION MEETING OF DECEMBER 9, 2004

The recommendation of staff, relative to Calendar Items C01-C30, and C32-56 were approved by unanimous vote of Commission Chair Steve Westly; Lt. Governor Cruz M. Bustamante; and Dave Harper representing Department of Finance.

**Regular Item 57:** A status report was presented to the Commission on a comprehensive review of marina leases to ensure that the leases and their provisions were comprehensive to ensure protection for the state's waterways. The commission approved by the item by a 3-0 vote with directions to staff to pursue as far as they could, under the context of current law.

**Regular Item 58:** A staff presentation was made to the Commission regarding the assignment of a lease to the Port of Stockton and construction of a new bridge. The Commission amended the lease assignment and issuance of a new lease conditioned upon the establishment of a truck replacement program funded by a percentage of the Port's profits from the west complex, and directed staff to work with the Port to describe a program that: 1) is consistent with and equitable when compared to the programs of other ports and 2) has the flexibility to allow monies dedicated to the program to be spent on other air quality improvement measures that produced a greater benefit than truck replacement. The item was approved by a 2-1 vote.

**Regular Item 59:** The Commission listened to a staff presentation pertaining to discussion of an invitation for the SLC to join the California Maritime Transportation Homeland Security Evaluation and Training Support Consortium. The item was approved as presented by a 2-0 vote.

**Regular Item 60:** The Commission listened to a presentation by the Executive Officer on the possible sale of our Huntington Beach office. Staff will bring the item before the Commission at a later date, once staff has collected all the proper information. This was an informational item; no vote was taken.
