#### **RECREATIONAL PIER LEASE**

#### **APPLICANT:**

Bernard John Atkinson and Carol Sue Atkinson, as Trustees of the Atkinson Family Trust, U/T/D Dated April 2, 1991.

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Carnelian Bay, Placer County.

#### AUTHORIZED USE:

Continued use and maintenance of an existing pier and boathouse as shown on the attached Exhibit A.

#### LEASE TERM:

Ten years, beginning November 29, 2004.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

#### **OTHER PERTINENT INFORMATION:**

- 1. Applicant owns the upland property adjoining the lease premises.
- 2. On July 6, 1995, the Commission authorized a Recreational Pier Lease with Bernard J. Atkinson and Carol S. Atkinson. That lease expired on November 28, 2004. The property ownership has since transferred to Bernard John Atkinson and Carol Sue Atkinson, as Trustees of the Atkinson Family Trust U/T/D Dated April 2, 1991. Applicants are now applying for a new recreational pier lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have

improved the littoral land with, and use the upland for, a single-family dwelling.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. 
