#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near South Lake Tahoe, El Dorado County.

#### AUTHORIZED USE:

Continued use and maintenance of an existing pier as shown on the attached Exhibit A.

# LEASE TERM:

Ten years, beginning March 26, 2005

#### **CONSIDERATION:**

Insurance:

#### **OTHER PERTINENT INFORMATION:**

- 1. Applicants own the upland property adjoining the lease premises.
- On May 3, 1995, the Commission authorized a Recreational Pier Lease with the Martin Family Trust. That lease expired on March 26, 2005. Applicants are now applying for a new Recreational Pier Lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.

3. 
