# **OTHER PERTINENT INFORMATION:**

- Lessees have permission to use an upland mariculture facility. 1
- 2. On April 9, 2002, pursuant to Minute Item 34, the Commission authorized a five-year lease (Lease No. PRC 8386.9) to the Lessees for kelp reforestation offshore Los Angeles and Orange counties. The lease was amended by the Commission on August 19, 2003, to include additional sites in Los Angeles, Orange and San Diego counties.

The Lessees have submitted an application requesting that the lease be further amended to include new sites offshore Escondido Reef, Point Vicente, Long Point-Marine Land in Los Angeles County and offshore Treasure Island in Orange County.

Lessees will use the following techniques: (1) outplanting of lab-grown juvenile plants; (2) seeding of existing fertile kelp into small mesh bags; and (3) transplanting local drift kelp. In addition, urchins in the restoration areas may be moved away from the juvenile kelp as needed, but only with the consultation of the State Department of Fish and Game.

As a result of Lessee's efforts, approximately 9,000 square meters of kelp habitat has been restored within the past three years in the areas offshore Los Angeles and Orange counties. Early data indicates a maturation of the kelp, a sustained reduction in sea urchin density and significant increases in the abundance and diversity of fish.

The expanded sites will be included in the Lessees' five-year monitoring effort and Lessees will continue to provide Commission staff with annual reports summarizing all activities and results.
