GENERAL LEASE - RIGHT OF WAY USE

APPLICANT:

Geysers Power Company, LLC 10350 Socrates Mine Road Middletown, CA 95461

AREA, LAND TYPE, AND LOCATION:

1.30 acres, more or less, of school lands near the city of Cloverdale, Sonoma County.

AUTHORIZED USE:

Construction, use and maintenance of a six- to eight-inch diameter water transportation line.

LEASE TERM:

25 years, beginning June 1, 2005.

CONSIDERATION:

\$450 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance with coverage of no less than \$1,000,000.

Bond:

Surety in the amount of \$5,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has the right to use the lands adjacent to the lease premises.
- 2. This Applicant is seeking permission to construct an 18,000-foot aboveground pipeline partially on State school lands to connect an existing water pipeline to an outlying project area, the existing Aidlin geothermal

area. The pipeline will contain tertiary-treated, city of Santa Rosa recycled water for injection of up to 1.44 mgd (million gallons per day) into the existing Aidlin geothermal project area. The pipeline will provide a year-round water source to sustain the production of steam to the existing Aidlin Power Plant, which is necessary for the continued operation of the power plant.

- 3. The pipeline will consist of a six- to eight-inch steel pipe laid on the surface and approximately 2,821 feet of it will cross four adjacent school land parcels, as shown on Exhibit A.
- 4. A Mitigated Negative Declaration and Mitigation Monitoring Program were prepared and adopted for this project by Sonoma County. The California State Lands Commission's staff has reviewed such document and as provided, in part, by section 15231, State CEQA Guidelines, "A final EIR prepared by a lead agency or a negative declaration adapted by a lead agency shall be conclusively presumed to comply with CEQA for purposes of use by responsible agencies.
- 5. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission has declared that all state school lands and submerged lands are "significant" by nature of their public ownership (as opposed to "environmentally significant"). Since such declaration of significance is not based upon the requirements and criteria of Public Resources Code sections 6370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by Title 2, California Code of Regulations, section 2954 is not applicable.




