**GENERAL LEASE – PROTECTIVE STRUCTURE AND  
RECREATIONAL USE**

**APPLICANTS:**

Tyson M. Shower and Hilary J. Shower

**AREA, LAND TYPE, AND LOCATION:**

Tide and submerged lands in the Sacramento River, adjacent to the Garden Highway, near the city of Sacramento, Sacramento County.

**AUTHORIZED USE:**

Construction, use and maintenance of a single berth uncovered floating boat dock, ramp, pilings, boat lift, and bank protection.

**LEASE TERM:**

Ten years, beginning June 20, 2005.

**CONSIDERATION:**

Single berth uncovered floating boat dock, ramp, pilings and boat lift - No monetary consideration pursuant to Resources Code section 6503.5.

Bank Protection - The public use and benefit; with the State reserving the right at any time to set a monetary rental if the Commission finds such action to be in the State's best interest.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance with coverage no less than \$500,000.

Other:

This lease is conditioned on Lessee obtaining authorization from U. S. Army Corps of Engineers, U. S. Fish and Wildlife Service, NOAA Fisheries, California Department of Fish and Game, State Reclamation Board and the California Regional Water Quality Control Board prior to the placement of the riprap, the installation of the boat lift and the

reconstruction and relocation of the ramp. All approvals are to be submitted to this Commission for review and approval prior to the placement of the riprap and the installation of the boat lift and the reconstruction and relocation of the ramp.

**OTHER PERTINENT INFORMATION:**

1. Applicants own the uplands adjoining the lease premises and have applied for a lease. Applicants qualify for a rent-free single berth uncovered floating boat dock, ramp, pilings, boat lift, and bank protection because the applicants are natural persons who have improved the upland with, and use the upland for, a single family dwelling.

2. The bank protection at this location mutually benefits both the public and the applicants. The bank protection of the River will have the additional protection from wave action provided at no cost to the public.

3. **Single berth uncovered floating boat dock, ramp, pilings and boat lift:**

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. **Bank Protection:**

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alterations to Land; Title 14, California Code of Regulations, section 15304.

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

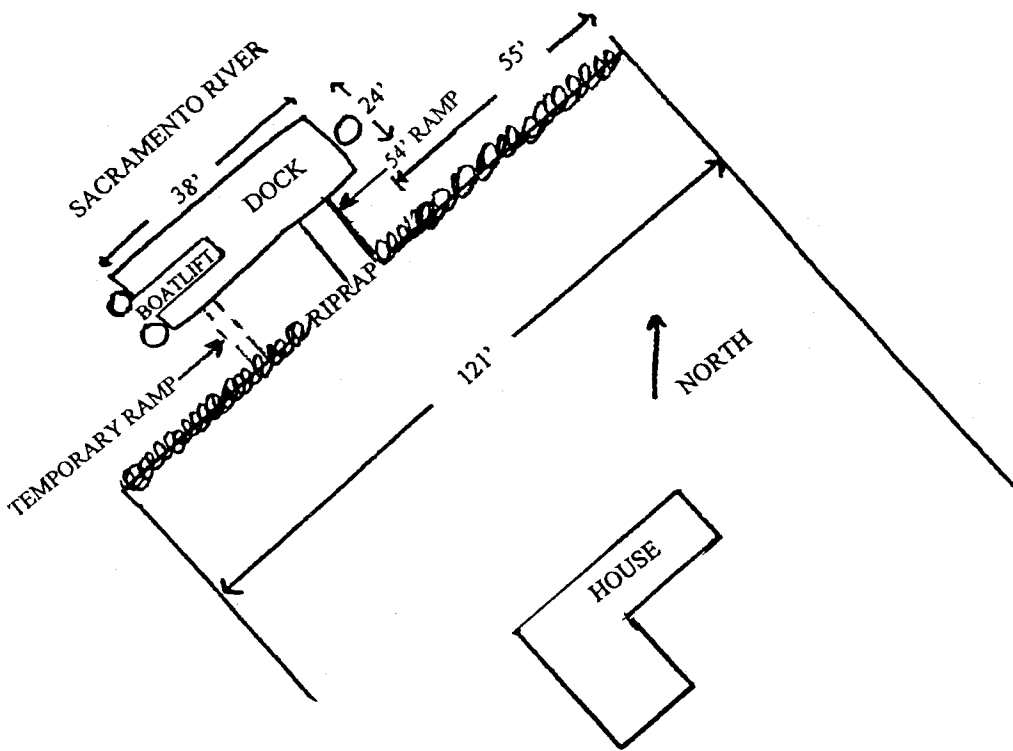
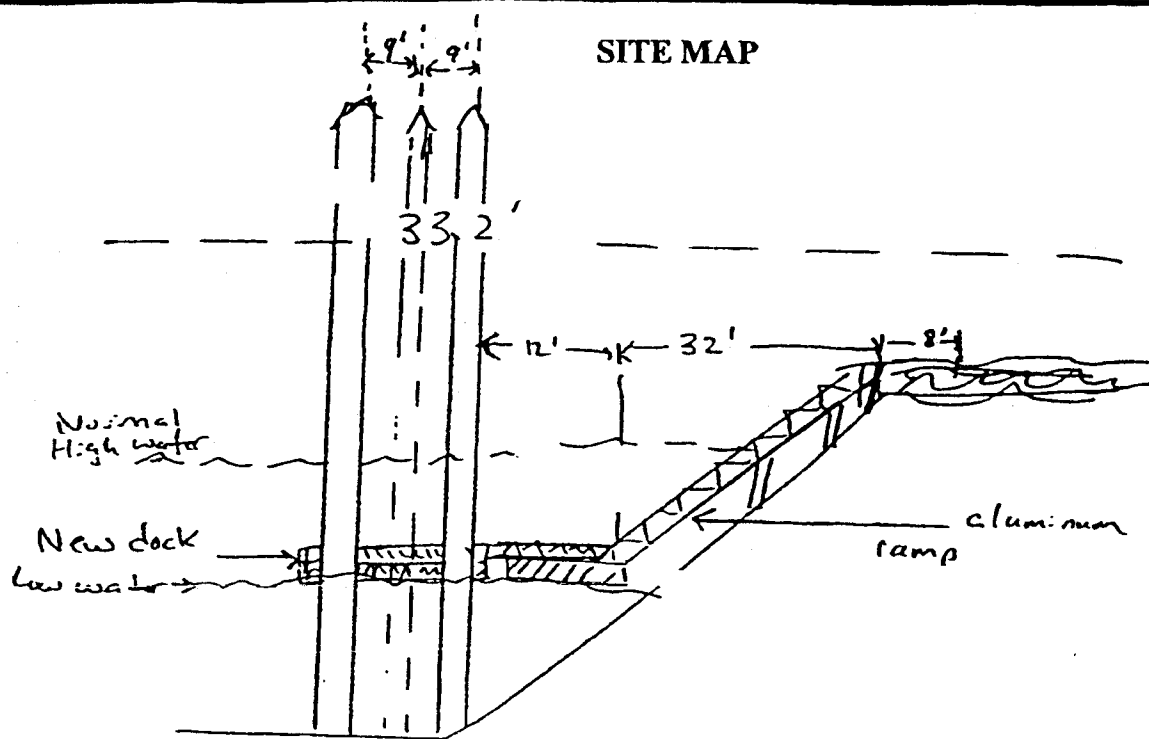

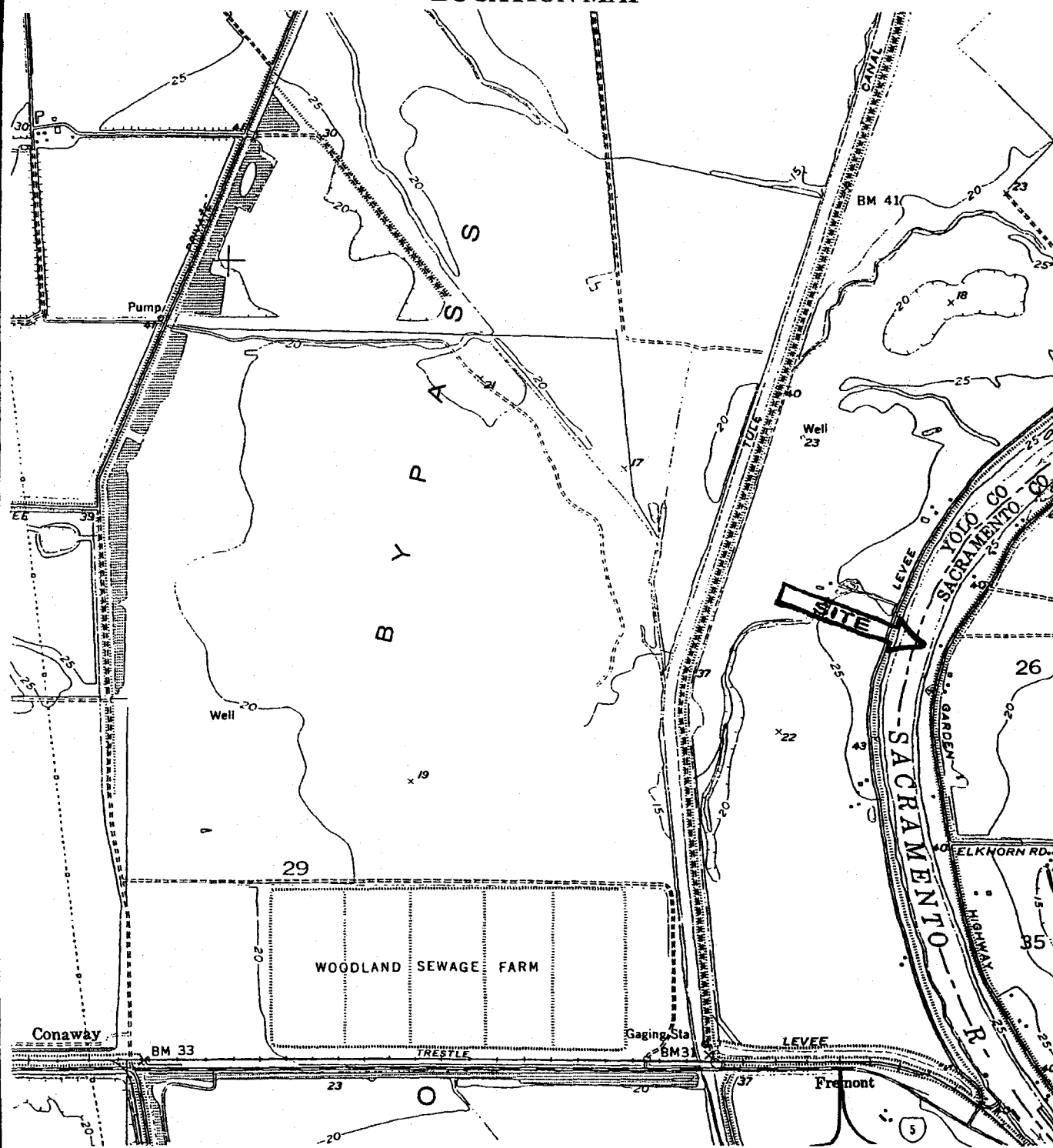
