REVISION OF RENT

LESSEE:

San Joaquin Delta Power Squadron

AREA, LAND TYPE, AND LOCATION:

0.20 acres, more or less, of tide and submerged lands in the filled and unfilled bed of the old channel of the San Joaquin River, near Headreach Island, San Joaquin County.

AUTHORIZED USE:

Continued use and maintenance of a 2,200 square foot floating dock and ramp; one 812 square foot floating dock comprised of two sections - a 69 foot long by 8 foot wide southern extension and a 52 foot wide eastern extension; one concrete pad improved with the wooden platform and patio roof, and one concrete pad with barbeque grills; and a retaining wall.

LEASE TERM:

25 years, beginning November 1, 1986.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised to \$600 per year, effective November 1, 2005.

OTHER PERTINENT PROVISIONS:

1. On November 20, 1986, the Commission authorized issuance of Lease No. 5212.1, a General Permit – Recreational Use to the San Joaquin Delta Power Squadron for the reconstruction and maintenance of facilities utilized for social, instructional, and charitable activities related to yachting. The lease has been modified several times to modify the authorized use and for rent increases.

CALENDAR ITEM NO. C22 (CONT'D)

2. The Lessee has requested that the Commission waive the rent for the facilities authorized under this lease. This request is based on the fact the squadron is a non-profit corporation with a public benefit mission to provide for boating education for its members and introductory boating safety classes for the general public. Under its current laws and regulations, staff cannot recommend waiving the rent for this type of facility.
3. Lessee has indicated siltation over the years has made much of the docking space useless. Staff reviewed the lease area and has revised it to include the actual useable area. Therefore, this reduction in use area also reduces the annual rent from \$1,910 to \$600 per year.

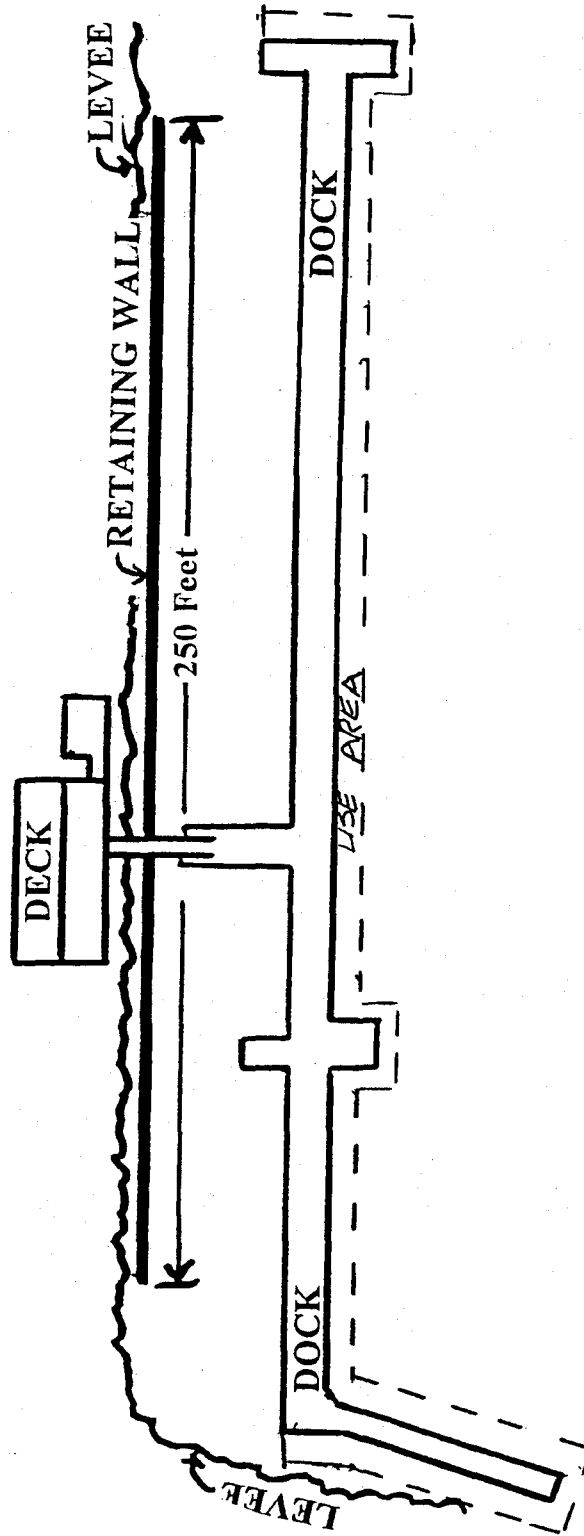

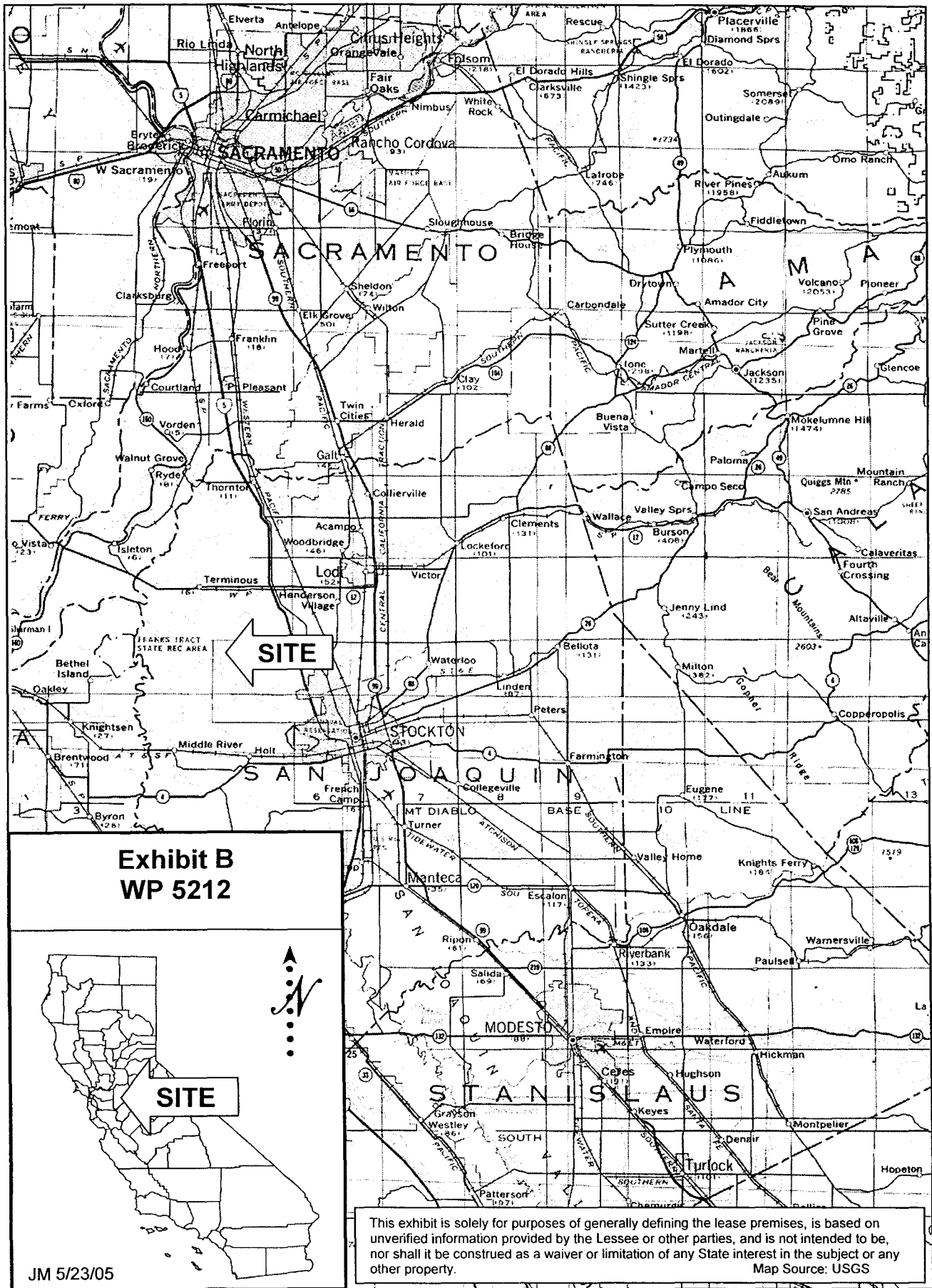
