Ten years, beginning January 1, 2000.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under the lease and has determined that land values have not increased sufficiently to warrant an increase in rent above the \$100 minimum for right of way leases. Therefore, staff recommends that the rent be continued at \$100 per year, effective January 1, 2005.

OTHER PERTINENT INFORMATION:

1. On June 27, 2000, the Commission authorized a ten-year General Lease – Right of Way Use to Mercer, Fraser Company (Lessee) for the annual placement and removal of a seasonal bridge crossing the Eel River near Fortuna. The placement of the seasonal bridge crossing is used to transport gravel removed during the Lessee's annual summer gravel extraction operations that are conducted outside of the active channel of the Eel River.





SITE MAP






PORTION SECTION 2 &3 T2N, R1W, H.M.
