AREA, LAND TYPE, AND LOCATION:

Approximately 80 acres of State 100 percent reserved mineral interest (RMI) school land (APN: 552-141-17) located in the W2 of the SW4 of Section 36, T8N, R7E, SBM, San Bernardino County and situated near Ludlow, approximately 45 miles east of Barstow, California, immediately north of Interstate 40.

BACKGROUND:

In February 2001, the California State Lands Commission (Commission) approved State Mineral Extraction Lease No. PRC 8282.2 to Washington Group International, Inc. (WGI) for extraction of rock, sand and gravel at an 80 acre site of State 100 percent (100%) RMI. The CEQA lead agency, San Bernardino County, had adopted a mitigated negative declaration and approved a conditional use permit and reclamation plan (MRP No. 93M-06) which authorized mining of 13 acres within the 80 acre site.

In October of 2001, WGI applied for and San Bernardino County approved a 51acre expansion (within the 80 acre site) of the Ludlow project after adoption of Negative Declaration SCH #2001071107 which replaced the earlier environmental document. On November 26, 2001, the Commission approved an application to amend and extend the lease to WGI. The amendment and extension modified the lease term commensurate with the County CUP and also increased the royalty rate, minimum annual royalty and financial assurance to a total of \$50,000.

WGI had secured a major road construction contract with Cal Trans for repaving a portion of Interstate 40 between Ludlow and Needles. Between September 1, 2001 and November 30, 2002, WGI sold approximately 418,000 tons of rock, sand and gravel and paid the State royalties of nearly \$200,000. An additional 36,105 tons were sold in the summer of 2003. No production or sales have occurred since due to a lack of market. Granite Construction believes future marketing exists including future Cal Trans and county road construction projects.

San Bernardino County Planning Department completed their annual inspection of the mine on June 15, 2005, and found all aspects of the CUP and Reclamation Plan to be in compliance. The east slopes of the mine have been reclaimed. Following this partial reclamation, the revised financial assurance being considered by the County is \$53,639.
