### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Donner Lake, near Truckee, Nevada County.

### **AUTHORIZED USE:**

Construction of a recreational pier as shown on the attached Exhibit A.

### LEASE TERM:

Ten years, beginning October 20, 2005.

### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

### **SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$300,000.

#### OTHER PERTINENT INFORMATION:

- 1. Lessees own the upland property adjoining the lease premises.
- 2. On February 21, 2003, Lessees obtained Commission authorization for the removal, relocation and reconstruction of an existing pier. The existing pier has since been removed. Due to landward obstacles not previously taken into account, Lessees need to change the design and location of the proposed pier.

- 3. Lessees have since transferred ownership of the upland to Wesley F. Wood and Julie A. Wood, Trustees of the Wood Family Trust Under Declaration of Trust Dated September 4, 1997. Staff is recommending termination of the existing lease and approval of a new lease.
- 4. Lessees qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.
- 5. **Termination of existing lease:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.
  - Authority: Public Resources Code Section 21065 and Title 14, California Code of Regulations, section 15060(c)(3) and 15378.
- 6. **Issuance of new lease:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

- 7. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. 


